Dear Sir,

I am a cane farmer growing around 20,000 tonnes of cane. All the vehicles on our farm are fuelled by diesel so I would like to stick with what I know.

When I first came into cane farming in 1980 I chose a diesel powered vehicle because the price of diesel was much cheaper than petrol. That is a very different story today. Queensland consumes more diesel than petrol, I wonder if that has anything to do with the reason that diesel prices have gone through the roof over the past 25 years.

In November 2002 diesel was .8912c per litre. By May 2005 it was \$1.951c per litre & in July 2005 (just after our crushing season had commenced it was \$1.3088 per litre. I have included a list of price increases given to me by our Harvester operator. The rise in fuel costs has added in the vicinity of \$7000 to my harvesting bill this year.

Harvesting is not the only area of cane farming that has been affected. All our tractor related costs have gone up. So has fertilizer, chemicals & anything that has to be transported to North Queensland, including food. The fact that much of our fresh produce has to travel to Brisbane before returning to North Queensland is absolutely ludicrous.

One thing really irks me. When we pay for our fuel the excise is added THEN the G.S.T. Isn't that a tax on a tax? Surely something can be done about that.

We are trying to economize by cutting down our trips to town, 26 km away & thinking twice before we go out to do tractor work. The question is always asked "Is it really necessary?"

Thank you for accepting my submission & I pray for some relief from the crippling prices that we have been subjected to over the past 6 months.
