### Submitter Comments:

In support of the bill. I propose some changes based on my personal experiences with children and youths. I have found my own son who is living in Asia was not able to fully understand what I am saying or keep an attention span over 30 minutes until he was eight years old to eight and a half years old. Therefore I see no point in sentencing a child for any crime with jail or juvenile detention time until they are 10 years old. Also, based on children doing silly things where they do not know the laws or being at home or school sometimes being influenced by others or making mistakes due to silly feelings. This could go on up to age 12 or 13. So based on these experiences of many children I have met and myself I have proposed the below laws. (1) When sentencing Minors as adults they be in the age group 12-17 years old. No younger. (1b) A minor 12-17 if he commits a crime and has a mental illness. (2) If a minor is under 12 years old who commits a crime, then pursue who is influencing them to do crimes like their family, people they talked to, people at schools or in the public should be pursued with charges and the boy interviewed about who they are and why he did this and was influenced his feelings about it. Which he may or may not be able to even understand due to his age.

To be deported the jails located in Darwin or the Northern Territory. Also, upon release to live in the Aborigininal camps or community in Darwin or the Northern Territory for a minimum term of life.(2) Australian South Sea Islanders, Maori or New Zealand type aboriginal minors who commit murder, who steal a car, commit gang crimes resulting in the death of others outside of their ethnic community, commit rape, commit grievous bodily harm against a person outside of their community without reason. To be deported the jails in the country of their ancestors which may be the country of their birth or their parents. E.G, New Zealand, Papua New Gineu, South Sea Islands, Cook Islands, other places. Upon their release for them to stay in their communities in these places for the minimum term of life.
