In making this submission to the committee, I am also asking for more than just confirmation of the bill but of the setting up of an investigation as to the true reason behind Mr. Vasta's sacking.

I wish to thank Mr. Katter for presenting this bill. It has been a long time coming for the House to recognise and restore a man it wrongfully dismissed. But as I have read, I have also realised that this case is one that appears incongruous to most. But I am convinced that this lies in people not having more of the evidence. A piece of evidence which lies in my having heard Mr Vasta's testimony at a Christian men's breakfast. He did not give one name of anyone involved but that through this he had learnt to trust the Lord to vindicate him.

The clue that opens one's mind to understanding is that he had been getting pressure, when on the Court Bench, to join the Masonic Lodge - he had refused, being a good Christian. The resulting tax issues and sacking appears to arise out of this situation.

So over the years I have prayed that God would avenge him of his enemies and re-instate him to the bench. He, himself, is a humble and righteous man and undoubtedly wants only his name cleared; but I truly feel there is an opportunity here for more - true and full Justice. At a prayer meeting before the last Federal election I met Mr Vasta's son, a federal MP. After, I thought I should contact Mr Vasta QC and encourage him; that God will indeed justify His servant.

So, it appears, Mr Katter you are the **hand of God** in this issue and to bring His Justice to bear. But let the Justice be full: there must be an investigation into the role of the Masonic Lodge in this issue. I have attached an example of an ex 33rd level Mason's testimony and a document using the famous evangelist, Charles Finney, and his comments on Masonry [he had to renounce it before God would use him]; so you can see for yourselves that this organisation is not what it seems.

But do not think they will accept investigation readily.

So my submission is:

- 1. The full implication of the Bill.
- 2. Mr Vasta is to be restored to the bench, even if he retires the same day.
- 3. ALL monies owed him: salary, superannuation, holiday pay etc., must be given to him.
- 4. The Premier AND Opposition leader must present an official apology from both sides and the check, before the full bench of the Parliament. The place from which he was sacked.
 - 5. This is to be done before the TV media and a half page ad taken out in the Courier Mail.
- 6. Preferably the current Grand Master of the Lodge, in Queensland, should also ask his forgiveness at this same presentation. Also they must pay an equal amount to that of the government.
- 7. An addition to the Bill that calls for a commission of enquiry to be set up to investigate the connection between the Lodge and the dismissal. e.g. were the judges that did the investigation into Mr Vasta, also Masons; the then Premier, the connection in the ATO that initially charged him with tax evasion they later restored his money with interest.
- 8. Because of the oath of the Masons to protect each other and the Lodge etc., it would require that a lie detector be used for witnesses and in the setting up of the committee.
 - 9. Legislation be passed that banned any new judges, at any level, from being Masons. All

existing judges would have to swear a new oath that overcomes the oath of a Mason. You cannot have justice if this judicial system is corrupted by this false religion, yet alone our parliament and government.

I know this may appear somewhat from out-there, but it is vital that this opportunity for true Justice be carried out. Please consider this submission carefully and see that there was something far more than just a case of unfair dismissal, but of outside and outright interference in the working of the Judicial system and our parliament.
