First i say, what rights does anyone have if it's not a legal right , our constitutional right is not accessible to anyone with out the money to get to the high court , our international rights are not covered by Australian law . why is it the people we elect to govern us have so fave not been willing to bring in laws that say that we will be protected from tyrannic ideals and any law that is ratified will have had all the checks and balances necessary to ensure the law is fair and consistent with what our basic human rights ought to be . we do not have the upper & lower houses to scrutinise the proposed legislation in Queensland so a bill of rights is necessary and would be, even with a second house . I have just touched on several points without going into full detail as my submission would be rather long if i was to go into great detail but i am sure you understand the negatives i am pointing to .

Now just a couple of examples of why Queenslanders need their rights protected

{1} the example of the late Newman government who rushed through laws with the promise they would of course be scrutinised before being enacted well that did not happen and the judiciary was ordered to incarcerate people because of who they were and not for what they had been accused of doing , solitary confinement without conviction not for their protection but to make them suffer for who they associated with . people were made wear pink only for humiliation this is the tyrannic behaviour i spoke of earlier .

{2} My son was arrested for a driving offence in front of my wife his arm was broken in two places by heavy handed police , my wife complained to the CMC who subsequently handed the investigation back to the police station where the incident took place , my wife then received a letter from the police from the same station that stated the investigation found nothing untoward happened to our son , after again contacting the CMC she was told the case would be filed with her objection noted but that would be the end of the matter , See these are the reasons people lose faith in our so called rights and basic protections .

i look at it like this if i was in court and i refused to swear on

the Bible or make an affirmation that i would tell the truth then i would not be believed, So it is if our government is not willing to bring in laws stating our rights will be protected then it can only be that they intend to or want the ability to pass legislation that infringes on even our basic of human rights , and why sign an international rights covenant and demand other countries protect their citizens rights but fail to enact the same international covenants here in Australia

{3} I am a member of one of the 26 motorcycle clubs that were declared without any right to fair or due process simply by the government of the day . I am an equal share holder in a property on the sunshine coast that has since October 2013 been a declared property which means that it is illegal for me to enter my own property, to maintain it or use it in any way. We have owned this property since 1993 and regardless of what the police will have you believe only one charge has been laid from the use of that premises and that was for supplying alcohol from the beer fridge in 2013 , and when three members showed up to our trial in Maroochydore police officer Wade Lee threatened if two of the witnesses did not leave immediately we would all be charged with association and be jailed immediately for six months, so our right to a fair trial was denied and we had no choice but to plead guilty , CMC investigation was handed back to Maroochydore police who said that he was right to tell them to leave. We are still required to pay the rates etc but are forbidden to enter or attempt to enter the property . Now the government of the day could of placed restrictions on the use of the premises that would of had the desired effect, but instead they set about removing our right to the use of our own property. As i said no money no high court challenge and no rights as a property owner.

These are just a few of the rights that i have been denied in the past couple of years there are more and many more against other people that i have talked to some of these are just failures of the current system that fails to protect our minimum rights . i am open to being questioned and can supply evidence if needed .
