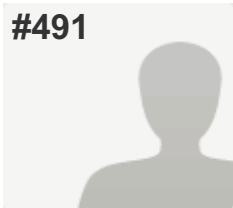

The Domestic Violence Magistrate got really irate that the police hadn't charged him for all his breaches and said I should have written to the Police Commissioner as he did breach the Order and was still breaching the order. I said they did and they refused to do anything as I'm in Family Court.

The children have a right to a childhood that its not marred by abuse and fear and a right to grow up without mental illness. There is a study called the Adverse Childhood Experiences Study. It states the higher the ACE score the more injuries illness people suffer from and a score over 6 means your life can be shortened by up to 20 years.
