

## Q5: Do you think that human rights are properly protected in Queensland? Why/why not?

Not for everyone, no. Why, is something that you learn when you go from one way of living to another, for example after something that happened to myself, I worked very hard to get to the job I got to, then there was a house fire, my fiancee died, I was in a coma for a week, when I awoke I was different. I am now ok with the fact that I am disabled, life is harder for me, it always has been to a degree but, realising that something was different didnt occur straight away. No one told me. Due to the amnesia I had after the fire, the things i forgot, everything I lost, I didnt want to let anyone cotton on to the fact that thigh where different for me. The fire was in 2006, and it wasnt until 2013 I realised I needed help, I had up to that point from 2009-2012 been constantly applying for jobs, watching this career and oppurtunity I worked my whole life to get slipping down and down a paygrade, I finally couldnt afford to live in my house anymore, and had to go through the process of realising not only was something wrong with me, how to get help, I suffer still to this day from a very broad thing called ptsd, I have trouble walking constantly due to my foot, that i nearly lost upon waking from the coma. And the whole time all i have heard is help is there, and it isnt. I am on the disabled pension now, since 2013 I have been sleeping on different peoples couches and in my car. the system wants to house me with people straight out of jail. I tried that for a bit, it got me in legal trouble, seeing as associating with criminals makes you one. I have a social worker, I phone her daily for help, she cannot help me, she rarely returns my calls. I am atm still in the process of waiting for housing, its been a long wait. I want a place so i can sort out some permanency in my life, it will be a miracle if I actually make it to get one. My application has been rejected for so many flippant reasons from the department of housing, that it is literally by definition discrimination, yet I dont indentify with a racial group, I am not a immigrant, I am a single white male, a father of two teenage daughters, housing/accomadtion effects every aspect of my life atm, with out permanancy in accomidation i cannot work towards something else, i cannot even help my children, and all this is due to a tragic event 10 years ago, and my comprehension centre in my brain being effected. I dont like thinking of my self as disabled because in my mind my friends and people I know living in a wheel chair, or battling a disease they are disabled. This is why it took me so long to realise i needed help, when i did, I tried to apply for housing. I think I originally applied in 2009, anyhow, If what i have just pointed out is not a human rights issue for gueenslanders I dont know what is. Housing prices are not affordable, services that we require are not available the further you move out, and the department that deals with this on a daily basis, is literally waiting for the social workers to either kill me by only offering me accomidation with criminals, or by making me spend my whole pension to obtain somewhere semi reasonable to get away from that situation. With my health the current way it is I will literally be dead in my car come winter anyhow. So.. whats wrong with human rights in queensland? you tell me.
