There are many conflicts of interest. When reports of violence, abuse and neglect are made they are ignored. There needs to be a specialist statutory body to investigate complaint in the area of mental health as the OHO is incompetent and does have he expertise, and ignores reports of abuse and neglect. There should be no confidence in the mental health system of Queensland. It is unsafe for women, as women are detained over-sedated and in mixed-sex wards. This is an area that need to be brought into 2016.
