1. Whether you have observed particular trends and type of criminal activity occurring in your particular region or across the State more generally

- Criminal trends are being repeated. Can only go down the same path unless you are shown a different way. Family trends repeated in the classroom, lack of education playing a big part in the propagating of or the repeating of the trend of criminal activity within our community – Disengagement -Unemployment - Domestic Violence – Sexual abuse - Theft – Drugs
- If children are not learning these patterns of criminal behavior are repeated in the next generation. We now see 2 and 3 generations of unemployment within families with younger members displaying the same behaviours.
- Housing costs and availability bring these families together Low socioeconomic areas develop as a result.
- The trend is that within our education system there are a growing number of children that aren't learning and therefore cant get out of the place that they are in or that their parents are in.
- The parents of these children also aren't particularly educated and consequently criminal activities become a solution for their need to make money. They have time on their hands to indulge in crime and also sexual abuse of their children.

2. What you consider to be the key social and economic contributors to crime;

As mentioned above.

We inquired of Morton Council as to what were the top community needs that they as a Council were trying to address. — Unemployment - Family breakdown, - children and youth disengagement - sexual abuse - setting children up for a future of criminal activities.

If the new approach of Justice reinvestment was linked to the "Mimi's House" project the initial successful pilot could be expanded into an area trial. At present:

Schools unable to cope with class sizes teachers employed to teach not parent children, responsibility to meet education standards and requirements and so 'naughty' children simply put out of classroom.

Growing number of these children – as former School Chaplains the founders of the Mimi's House project dealt with a number of them.

d. Alternative dispute resolution.

Established Mimi's House (Grandma's House) 2013 Grades 1-5

3 local schools contributing at this point in time Grade 5 students as they realize this was a 'last chance option for their grade 5's -10 children per day for 4 days -40 children - waiting list exists for positions.

Referral Process

Mimi's House is partnering with local schools in the Moreton Bay region. Children are referred to the program by their school's Guidance Officer (on the approval of the school's Principal and the child's parent or carer).

Programs Used

Mimi's House uses endorsed programs such as 'Friends for Life' and 'My Life Rulz'. These two programs are specifically designed to build the child's self-confidence and self-efficacy.

Adult Child Ratio

1 Adult – 4 Children

Transportation

Children who participate in the program will be collected from their home and transported to Mimi's House in the morning and will be returned to their home in the afternoon.

Outcomes

- Respect for themselves and others
- An ability to regulate their emotions
- Teamwork
- Delayed gratification
- Self-control
- Communication skills
- Hygiene and self-care
- Gardening, craft and/or other practical skills

As mentioned this is a pilot project through which we are developing our 'best model' and 'best practice'.
