Submission re: Liquor (Rural Hotels Concession) Amendment Bill 2017

With reference to the policy objectives and reasons for the Liquor (Rural Hotels Concession) Amendment Bill, Clubs Queensland supports not only the intentions of the Bill but also the proposed model of achieving the policy objectives.

However, it is Clubs Queensland's belief that there are some competitive inconsistencies which shall arise within those communities affected by the proposed regulatory amendments as they currently stand, as outlined below:

- I. The Liquor Licence Fee schedule, published by the Office of Liquor and Gaming Regulation stipulates the Base Fee for a Commercial Hotel Licence as \$3,507.00. Should the Bill be passed, this would result in the fee for a Commercial Hotel Licence in a "very remote area" being reduced to \$350.70.
- II. Currently, a Community Club with 2000 members or less operating in the same "very remote area" faces a base licence fee of \$648.00 – some 85% higher than what the commercial operation in the same area would face should the Bill pass through the House un-amended.
- III. Similarly, a Community Club with more than 2000 members or less operating in the same "very remote area" faces a base licence fee of \$2,857.00 – some 714% higher than what the commercial operation in the same area would face should the Bill pass through the House un-amended.

As evidenced above, the passage of the Bill in its current form creates a financial benefit for commercial operations within these very remote communities, whilst retaining a financial impediment for community-based operations in those very same communities.

It is Clubs Queenland's belief the impact of this Bill could potentially apply to some 32 Clubs operating in very remote areas of Queensland, as listed below.

In doing so it recommends the Committee also give consideration to either amendment of the Bill, or the introduction of a further Bill to address the financially uncompetitive environment visited upon the community clubs sector as a consequence of the currently proposed amendments.
