# Submission to the Inquiry into the Strategic Review of the Office of the Queensland Ombudsman

The report is into the Strategic Review is a valuable resource and the 72 recommendations provide guidance to the Parliament, the Ombudsman and the wider community on changes that could help to improve the value of the Ombudsman function in Queensland.

As I am not sufficiently familiar with the Queensland context I will restrict my observations in this submission to one aspect of the process and a general observation about collaboration between integrity agencies.

#### 1. The role of periodic statutory reviews

I have reviewed the role of periodic statutory reviews of Auditors General (see the reference list below) and the observations arising from this work might assist the Committee in considering the benefits of Strategic Reviews in the Queensland context.

From my initial review of the Strategic Review report I didn't see any cross-referencing to the process or findings of the most recent Strategic Reviews of the Queensland Audit Office and think there may be some benefit to the Queensland Parliament (and other Parliaments) for some comparative analysis of these two parallel streams of review, particularly as the Queensland Ombudsman is the only Australian Ombudsman to be subject to periodic statutory reviews.

### 2. Collaboration between integrity agencies

The Strategic Review report makes insightful comments on aspects of collaboration with other integrity agencies and it might assist the Committee to consider these aspects of the report in the broader context of this collaboration in different jurisdictions (see the reference list below). While collaboration is sometimes seen as axiomatically good, the benefits should be considered alongside the risks involved and concerns that have been raised about certain practices.
