# **Key feedback**

The Queensland and Northern New South Wales Branch Committee:

- welcomes the introduction of the Bill as the committee believes passing of the Bill will
  provide a fairer and more inclusive community for all Queenslanders by creating an
  overarching human rights dialogue across all arms of government;
- 2. supports the passing of the Bill as soon as possible to provide enforceable protection of human rights for all Queenslanders;
- 3. believes enforceability is critical to create a fairer and more inclusive community for all Queenslanders, particularly for people who are more vulnerable to experiencing violations of their human rights, including;
  - children;
  - people who identify as Aboriginal and Torres Strait Islander;
  - people living with disability and mental illness;
  - people in later stages of life; and
  - people who identify as lesbian, gay, bisexual, transgender, queer, or intersex; and

4. commends the government and strongly supports the inclusion of a complaint mechanism in the Bill, and is also supportive of the Bill being amended to enhance the complaint process though the inclusion of a mechanism for a human rights complaint to be taken to a court or tribunal.
