Re: Call for submissions - Monitoring of Places of Detention (Optional Protocol to the Convention Against Torture) Bill 2022

The Australian Workers' Union of Employees, Queensland ("AWUEQ") thanks the Legal Affairs and Safety Committee for their email of 5 December 2022 calling for submissions on the Monitoring of Places of Detention (Optional Protocol to the Convention Against Torture) Bill 2022 (Qld) ("Bill"). The AWUEQ makes these submissions accordingly.

We note that Part 4 of the Bill provides for the United Nations Subcommittee on Prevention of Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment ("Subcommittee") to interview any person at a place of detention during a visit to that place of detention. We further note that a person may consent to be interviewed, and can withdraw their consent at any time.

The AWUEQ is concerned that the consent protections provided in clause 16 of the Bill do not go far enough to protect the interests of our members. We would prefer to see the current protections continue in the Bill along with additional safeguards for employees who maybe interviewed. Those safeguards should include amending the Bill so that:

- employees are aware of their rights not to consent to be interviewed;
- employees are aware of their rights to withdraw consent at any time;
