

Submission to the Legal Affairs and Safety Committee

Queensland Births, Deaths and Marriages Registration Bill 2022.

I am writing regarding Part 5 of this Bill that will be forced on women and our children.

I would like the Committee to advise the parliament against passing this dangerous self ID law or at least include sex not sex descriptor or gender.

My name is Danielle El Hayek. I am a Lebanese immigrant and a very proud and law-abiding Australian citizen... I helped campaign for LGBT rights in the middle east in the 90's, almost got killed defending a trans prostitute from a 3-man attack and took care of a gay Philippino man (a colleague) who got viciously attacked due to his sexuality and spent time in ICU in Riyadh Saudi Arabia.

I am also the single mother of a teenage daughter who was born in this great country.

As a middle eastern woman, I worked very, very hard all my life to earn the right to live in Australia leaving my whole family behind so I can release myself of the shackles of strict gender roles that are imposed on my sex in Lebanon.

One of the most important reasons I wanted to become Australian is the equality and equal status as human beings that women hold in this society. Was that an illusion?

I cannot believe that Australian women are losing our rights at lightning speed while my sisters in Lebanon and Saudi Arabia (where i lived for many years) are still fighting for basic rights.

A man now can become a woman, a very special protected woman, just because he says so. He gets instant access to everything women fought hundreds of years for, just like that...

I fought very hard for the freedom and safety Australian women enjoyed and I finally got it after decades of struggles. I thought my daughter would not have to fight the way I did. Now I'm facing the prospect of her growing up with way fewer rights than I grew up with in the middle east.

In March 2022, a bearded man in a dress followed her into the women's toilets at the cinemas and lurked outside her toilet door. She called me freaking out. I asked her to say loudly "I'm calling the police" until he left...

When I called my local MP's office I was asked: "Did your daughter ask for HER birth certificate?"...my daughter was 16. She has eyes, ears and a brain...he was a middle-aged man. Then I was told to contact the Attorney General.

All my emails to Shannon Fentiman (Attorney General/ Minister for Women) went unanswered.

It took me 6 months of persistent calling to get a meeting with my local MP.

I very quickly learned about the self ID laws that are being pushed in secret and unopposed on an unsuspecting public and without any discussions....I was horrified.

- What does that mean for my daughter's safety and mine?
- I read the proposed law. It is so flimsy any man with indecent motives will exploit it (with the thousands of examples from other states and countries). How am I going to keep her safe?(Please find attached many examples)
- What about our cultural values? What about the rights of my Muslim/Jewish/Hindus/Buddhist sisters, rights to use our private spaces in peace and dignity without male bodied people present?
- As an immigrant Australia amazed me with the strict immigration laws and border safety. Self ID will weaken all this. Anyone can change their ID EVERY YEAR. This is insanity.
- How easy will it be for sex traffickers to acquire new victims and so easily change their identities. A new birth certificate for a minor only requires an adult and a statutory declaration (we all know how well intended and moral sex traffickers tend to be)...Can you see how terrifying this is?
- What will happen when a mother or father kidnaps their child/ren and takes them interstate and overseas without the other parent's approval when changing the IDs of said child/ren becomes so easy? How are these children going to be found and recovered? My ex-husband threatened me with similar actions years ago. But then I had the law on my side. What will happen now?

- As a middle eastern woman who believes in science and that our human species is binary and can't change sex even if you deeply feel it in your soul (what does that even mean?). We are primates, not clown fish or eels. How will my gender critical views and my personal cultural beliefs be dealt with under these faith-based laws? The basic FACTS that humans can't change sex, only women can give birth are now controversial and deserving of punishment.
- Why would you let such a small minority of people dictate laws that are going to deeply affect all aspects of the lives of 50% of the population (females)? What happened to our precious Australian cultural and religious diversity? Why are the people who say they are not their natal sex, not fighting for their own spaces instead of forcefully invading ours? Why are their privileges trumping everyone else's rights? They already have the same human rights as everyone else.
- How are you reconciling: "An increased focus by government on appropriate data use and protection, and the prevention of identity theft and fraud, including ensuring life event registration systems are not misused for fraudulent purpose", with being able to legally self ID into another "sex descriptor"? so easily?

I urge you to consider ALL the ramifications on women like me and the future and safety of my daughter and other children.

When the word WOMAN becomes offensive and the Minister for Women herself is blocking us on social media and blocking/not responding to our emails what recourses do we have?

I will forever be thankful if my questions are answered and replied to. Thank you.

Queensland Births, Death and Marriages registration Bill 2022.

I am against Part 5 of the Bill.

It is obvious from the Attorney General's statement to parliament that this part of the bill is specifically included to cater to gender ideology. She made misrepresentations to parliament regarding gender ideology and it's importance to part 5 of the Bill. She made statements about transphobia, evidence highlighting safety privacy and dignity of women as compared to men who claim to be women. She stated she met with trans and gender diverse people but omitted that she refused to meet with women's group to discuss there concerns.

Submission to the legal affairs and safety committee

Qld births, death and marriages registration bill 2022.

I am against part 5 of the Bill. Please consider my statements honestly and scientifically and reconsider Part 5 of this Bill.

I'm writing to you as a veteran nurse of 27 years who has worked in 4 countries and taken care of trans patients.

Back in 2009 when I did my citizenship test, I don't remember the questions:

1. Do you believe that humans can change sex?
2. Do you believe men can have periods and give birth?
3. Do you believe women can have penises?

Because Part 5 encourages people to think they can change sex with drugs and surgeries the medical field is ignoring its oath **"FIRST DO NO HARM"**.

What happened to science and scientific truth? **"BELIEVE THE SCIENCE"**, the Queensland Government kept telling us regarding the pandemic, and still is.

Incredible claims require back up and proof and this Bill claims that humans can change sex. If you support this Bill, please be able to back up this supernatural claim. If you think humans somehow can change sex, despite no record of any human ever changing sex ever happening, then the onus is on you to prove it. I will happily change my mind if I'm ever provided with evidence of this biological miracle.

Trans Ideology is the basis of Part 5 of the Bill.

Sex and gender identity are not the same. Sex is a biological reality and gender is a made-up social construct.

There is no clear and scientific definition for "trans". There is no relevant reason to change an incredibly important document such as a birth certificate based on an ideology.

According to this Part of the Bill biological reality is suspended.

Men with mental illness such as autogynephilia who has several comorbidities with other sexual fetishes) and a 12-year-old child with gender dysphoria and body dysmorphia have nothing in common.

There are many psychological reasons that children would want to revoke their birth sex, especially girls, but they are receiving non-reversible, disfiguring surgeries, sterilization and lifelong medical/pharmaceutical treatments instead of proper non-evasive psychological help.

We don't allow children to make decisions about alcohol access, getting tattoos and driving cars but this Bill suggests we trust them and totally believe they have the capacity to make decisions about permanently altering their body to the detriment of their health. Children cannot make informed medical consent. It is impossible.

Parents who will try desperately to keep their children safe and out of harm's way will be possibly punished by law, and have their kids removed from them like the parents jailed in WA and VIC.

ROGD (Rapid Onset Gender Dysphoria) relates to the huge sudden increase of children claiming to be the opposite sex and the online social contagion that is causing it. The medical industry with the blessing of such a law is sterilizing children and permanently disfiguring them as a social fad.

Doctors are prescribing off label puberty blockers and dangerous cross sex hormones without proper studies on the long-term health ramifications on our society and will cause strain on precious Medicare resources. (Find attached a website that will explain this in detail).

Psychologists, psychiatrists, and therapists are forced to follow the affirmation only model or face deregistration in Queensland, while other therapists who really want to treat the psychological root cause of issues are being silenced. If my daughter's anorexia nervosa was affirmed in 2017 she wouldn't be with us today.

Listen to the "detrans" community that is growing every week. They have gone through it all and will have to deal with harmful ramifications for the rest of their lives.

Mainly autistic and mentally ill kids and adults are targeted by this ideology. Pharmaceutical companies and the medical industry take advantage of our most vulnerable people.

Nursing courses and schools promote and push these extremely non-scientific teachings. What kind of future society are we building when biological teenage boys in our school are terrified of getting pregnant once their sex life starts?

Examples of the ramifications of falsifying your birth sex if you need medical treatments will be prostate, cervical and breast screenings being missed. Males can die horribly if they receive a blood transfusion donated by a woman who had previously been pregnant or miscarried. Heart attack symptoms are very different between men and women. There are many other examples.

Doctors and nurses like me who know and have seen and treated the horrible ramifications of medical transition don't want to be a part of this. Would: "we were just doing our job and following orders" get us out of jail when the criminal proceedings start pouring in. AND there will be a deluge...the Nazi nurses who only followed Mengel's orders and were charged at the Hague were promptly executed and rightfully so.

Biology and mother nature doesn't care what people feel about their gender identity and will keep doing her thing. Every cell of every body has sex markers and screams biological reality, and humans cannot escape reality no matter how many birth certificates are lied on.

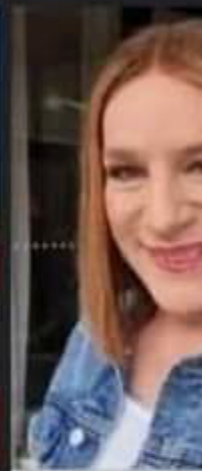
