The Gold Coast Justices Association Incorporated has 83 members who are all volunteers. There are no paid staff in our organisation. All management committee members volunteer their time freely to manage the organisation. No one receives any payment.

Our members are Justices of the Peace and Commissioners for Declarations, offering a service to the community by witnessing important legal documents.

The Gold Coast Justices Association manages five Justice of the Peace signing centres across the Gold Coast.

All signing sites are in secure office spaces within a shopping centre. These include: Robina Town Centre, The Pines at Elanora, Harbour Town at Biggera Waters, My Centre at Nerang and Q Centre at Mermaid Waters.

Organisational Mission

The Gold Coast Justices Association Inc. is a not-for-profit organisation dedicated to serving the public by enhancing access to justice and promoting the safety and security of community members. We aim to achieve the following objectives:

Consideration could be given to offering a discount to those people looking to become a Justice of the Peace in their retirement.
