#### 1. Volunteering in Queensland

- contributing value of volunteers is immense;
- as a volunteer I gain personal satisfaction;
  - I value every person I assist and find it most beneficial to hear, on the other side of the phone call, that someone has found peace in the direction they will take and do not feel lost.
- Email support takes time to resolve but that also brings great joy of accomplishment;
- many organisations have volunteers and sometimes people just don't realise that they are dealing with volunteers, which can be sometimes quite challenging; and

#### 2. <u>Prospective Volunteer Views</u>

  - This is not a good reason to volunteer. Very challenging and I have had to have counselling to recover.
- Some poor communication due to stress and not coping with the workload which has caused some grief to other people;
- volunteers are not always treated fairly or with respect;
- We are often very hard on ourselves for being out of line or not being able to do enough;
- Some volunteers work very long hours, just to keep things moving along;
  - This is not sustainable.
- volunteering comes from the heart;
  - The reward is self-satisfying and certainly has no financial reward or even credit anywhere.
- giving back to others to continue the work that others have done for you;
- Engaging new volunteers is difficult;
- time is important to many people and giving of their time is something that many people struggle with.
- there is always someone you can help;
  - o It takes initiative and commitment to volunteer anywhere effectively.
- learning new skills and being confident using them.

## 4. <u>Unique Challenges – Diversity of People</u>

- I'd be happy to have anyone volunteer who would like to give to the Home Educating community their experience or support.
- We all can support each other.
- Respect and solidarity for something is more important than our separation and grievances that people project upon others.
  - o It's how we go about it that counts, not what we look like or believe.
