No preamble for the Queensland Constitution – at this stage

The Queensland Constitution should not contain a preamble at this stage according to a Queensland parliamentary committee.

The Legal, Constitutional and Administrative Review Committee of the Queensland Parliament asked the people of Queensland whether the Queensland Constitution should have a preamble and, if so, what that preamble should say. Submissions received from 134 people and organisations suggested that, although the enactment of a preamble to the Queensland Constitution would create an opportunity for a strong unifying statement of the aspirations and values shared by Queenslanders, finding consensus about those values and aspirations would be a very difficult task.

Reasons for the committee's conclusion include:

- insufficient public support and consensus;
- concerns about the legal effect of a preamble;
- queries as to whether the extensive consultation required to develop the form and text of a preamble is an effective use of resources; and
- the likelihood of having to revisit any preamble if there is a change to a republican system of government.

Dr Lesley Clark MP, Member for Barron River and chair of the committee, says, "The committee's decision not to recommend a preamble will no doubt disappoint many members of Indigenous communities and organisations that responded to the review." Indigenous people and organisations suggested to the committee that a preamble could be a vehicle for reconciliation, providing constitutional recognition of Aboriginal peoples and Torres Strait Islanders.

Dr Clark says, "The committee has sympathy for that view, and we note a recent amendment to Victoria's Constitution recognising Aboriginal peoples."

"A similar substantive amendment to Queensland's Constitution is an alternative mechanism to that of a preamble which could be considered by the government in the interests of further fostering reconciliation with Indigenous Queenslanders."
