***A PREAMBLE FOR THE QUEENSLAND CONSTITUTION?  
ISSUES PAPER JUNE 2004***

The only recommendations of the QCRC which have not yet been reviewed by the LCARC relate to a preamble for the Queensland Constitution. The Constitution of Queensland 2001 (the Queensland Constitution") currently does not contain a preamble. The QCRC recommended that 'to emphasise the new foundations of the State's constitutional regime' there should be a preamble to the Queensland Constitution and that it should state:

***Since ( DICTIONARY MEANING: after that; from or after that time; subsequently; and so on) the Australia Acts 1986 no law made by parliament of the United Kingdom shall extend to the State of Queensland.***

**THIS IS A SCAM : SINCE (meaning *From or after*) the Australia Acts 1986 *NO law made by parliament of the United Kingdom shall extend to the State of Queensland***

**THIS MEANS : All laws that have formed the foundation of our legal system that originated from England. That included, but are not limited to:**

Magna Carta. 1297  
Habeas Corpus Act 1640  
Bill of Rights 1688.  
Act of Settlement 1701  
Commonwealth of the Australia Constitution Act 1900. (Imp)  
that includes chapter 9, The Constitution of the  
Commonwealth.

The Australian Constitution is the only head of power, that authorizes and allows Queensland to function as a State with in the Federation created by the Commonwealth of Australia Constitution Act. This is set out in the Commonwealth of Australia Constitution Act 1900, section 6 Definitions, and at all times is subject to section 5, Operation of the Constitution and laws.

The Queensland Parliament is not authorised by the Commonwealth of Australia Constitution Act to repeal or amend the Constitution or any Imperial Act in force in Queensland , prior to 1900, when Queensland was a Colony and the Constitution itself reserves the right of Amendment to the people by section 128.

The Australia Act 1986 purports to change the relationship between her Majesty and the Australian people. But unfortunately , it can have no legal force or effect , because the Australian Parliament did not ask the Australian people for their consent to the purported changes pursuant to section 128 of the Australian Constitution. There was no referendum , therefore , the Australia Act 1986 is invalid.

***Previously the Parliament of the United Kingdom was the ultimate authority for the Acts, Laws and Documents relating to the Constitution of the State of Queensland.***

***We, the people of Queensland wish to continue as free and equal citizens under the Rule of Law, and to be governed in accordance with the democratic processes contained in this Constitution. A stream cannot rise above its source. The Parliament of the State of Queensland is a subordinate legislature and cannot rise above the source of its authority, the Australian Constitution.***

***And being within the federal Commonwealth of Australia, we recognise we are subject also to its Constitution, (Recommendation 3.1): This clause Contradicts Clause 1. You cannot destroy the Laws of England , that were Part of the Received Law of the Constitution pursuant to Section 118. Then turn around in this clause and pretend that you are still subject to the Australian Constitution.***

**This preamble is meaningless, even if it was included in the Queensland Constitution. It has no legal force or effect and does not form part of the Constitution of Queensland and serves merely to confuse and trick ignorant Queensland electors into thinking and accepting that it is valid law.**

**To even make these suggestions may in fact be an offense against the statute laws of Queensland and the Commonwealth.**
