Re: Inquiry into the opportunities to improve mental health outcomes for Queenslanders

Dear Committee

Thank you for providing Family Drug Support (FDS) with the opportunity to provide a submission to your Inquiry.

As you may know, FDS is the only national non-government organisation which provides nonjudgemental, non-directive support and information to families, friends and carers of people who have problematic alcohol and other drug use. Since its inception in 1997, FDS has staff and volunteers to assist in the development and delivery of evidence-based programs including a national 24hour toll-free telephone support line, a wide network of support groups for families affected by someone else's alcohol and other drug use and educational programs and online information and services. Currently, FDS has contact with thousands of families every year including Queensland's urban, rural, and regional communities.

There is a wealth of evidence regarding the health, social and economic impact of alcohol and other drug use in communities. Some research has identified the social cost to the Australian community as being in excess of \$15 billion. Addressing alcohol and other drug use can have a very positive impact on family life, the health and safety of communities and just as importantly on the cultural and business opportunities in a community. FDS seeks to provide families with a set of opportunities to learn and understand about alcohol and other drug use and ways of dealing with its consequences. As these families often feel a sense of shame with the alcohol and other drug use related problems they face, they also often tend to reduce their level of community participation in a range of activities. This can create significant economic and social impacts in smaller communities and reduce the potential for growth and development. There is little doubt that addressing alcohol and other drug use problems will lead to many positive outcomes across the community and FDS has proven itself to be the most effective service in addressing the issues faced by families.

Accordingly, our mission quite simply is to assist families throughout Australia to deal with alcohol and other drug use issues in a way that strengthens relationships and achieves positive outcomes.

A critical feature of the alcohol and other drug use problems often raised by communities is the devastating impact it is having on families and community safety in the community. While the delivery of services for affected people is critical it is also important to help families deal with the issue as this will have a strong influence on the current and future behaviour of the person with the alcohol and other drug use problems.
