Dear Minister for transport,

My name is Suresh Narayanan and I have been a lessee of a taxi licence for the past ten years. Since international ridesharing Uber came into Queensland (end of 2014), my livelihood has been affected. As of my situation today, I am borrowing money from my home loan equity to make my ends meet. To put it simply, **LAM GOING BACKWARDS** in regards to my day to day living and unable to provide my family of four the basics, as a dad would provide for his family in Australia.

Because of your department's inability to listen to the industry, yet have regulated this rideshare company in **namesake**, which is well known for its rogue attitude to every regulation, a highly regulated taxi industry in our state, **has fallen casualty.** Being a Queensland taxi driver for the last ten years, I have pride providing high standards of service for the Queensland community.

Because of the Labor government's lack of vision, our state has followed other states like a **herd of sheep.**

In 22 years of living in a great country like Australia, the future for our children and the following generations **have been ruined** by successive governments, federally and locally. From Prime Minister **Mr Paul Keating** to current Prime Minister **Mr Malcolm Turnbull** and Premier **Mr Wayne Goss** to **Ms Annastacia**, all of them talk about multinational companies not paying their fair share of tax.
