Good Morning,

I supported Wild Rivers because as a TAEPITHIGGI man I want to see the protection of my land and of the Steve Irwin Wildlife Reserve. I do not want a mine on my story places. If they go, I don't want to live here, I don't even want to live in Weipa.

I am a Director of our Elder Board and I am an Australia Zoo Ranger on the Reserve.

Our archaeologist showed important places in this area, and Cape Alumina just want to make money off us. We can't see any benefit; we already have a deal with Rio. Why do we need to deal with another mine?

Clans near us are worried about dredging of the Port Musgrave, but I can't speak for them. I can only tell you we want protection of our land. We have a Native Title claim going through. What use is it, if we lose our heritage?

There is no proven need for a mine here. We want to see a better solution than the Wild Rivers legislation. We need to see that this Bill will protect the Steve Irwin Wildlife Reserve directly, by name.

I am happy to meet you, thank you.

Attached is an MOU, which we have developed with Griffith University. This shows the value of the Reserve for indigenous people and for science. Also attached is information on Land and Sea Cultural Heritage.

### MEMORANDUM OF UNDERSTANDING

#### THIS MEMORANDUM OF UNDERSTANDING is made on

2013.

BETWEEN: **GRIFFITH UNIVERSITY** (ABN 78 106 094 461), a body corporate established

pursuant to the Griffith University Act 1998 (Qld) of 170 Kessels Road,

Nathan, QLD 4111 ("Griffith")

AND: CECIL ARTHUR (as an authorised representative of the Taepithiggi Elder

Board and the Taepithiggi people) ("Mr Arthur").

#### **TERMS OF UNDERSTANDING:**

- 1. Griffith anticipates that it will enter into an Access Agreement with Silverback Properties Pty Ltd as Trustee of the Terri Irwin Family Trust, owners of the Steve Irwin Wildlife Reserve ("SIWR"), to access the SIWR in order to identify and collect samples of biological resources ("Samples").
- 2. Mr Arthur is a member of the Taepithiggi people, the traditional indigenous land owners of the land on which the SIWR is situated. Mr Arthur is also an authorised representative of the Taepithiggi Elder Board and for the purposes of this MOU represents the traditional indigenous land owners, the Taepithiggi people.
- 3. The Taepithiggi people are the holders of the indigenous peoples' traditional knowledge for the land upon which SIWR is situated and may have indigenous/traditional knowledge with respect to some of the Samples which may be collected by Griffith.
- 4. During Griffith's access to SIWR, Mr Arthur will provide guidance to Griffith's researchers and may in this process communicate indigenous peoples' knowledge in connection with the Samples being collected by Griffith.
- 5. The parties see value in bringing their expertise together to assist with drug discovery research.
- 6. If Griffith obtains and uses any Taepithiggi peoples' traditional knowledge in connection with any commercialised or potentially commercialisable drug discovery research, Griffith will ensure that the Taepithiggi people receive an equitable share of the benefits arising from such research and, if necessary, enter into a benefit sharing agreement with the Taepithiggi people or a legal entity representing the Taepithiggi people at such time.
- 7. The parties agree that this Memorandum of Understanding is not a formal legal agreement giving rise to any legal relationship, rights, duties or consequences, but it is only a definite expression and record of the purpose of the parties to which the parties are bound in honour.
- 8. This Memorandum of Understanding will be effective when it has been signed by both parties. Either party may withdraw from the understanding at any time, although the giving of a reasonable period of notice is preferred.
