## RE: Invitation to make a submission to an inquiry into the Water Supply Services legislation Amendment Bill 2014

## **Views of Cairns Regional Council Water and Waste**

Cairns Regional Council is largely supportive of the legislative changes designed to reduce the regulatory burden, however until the release of the KPI's discussed in the legislation it is difficult to assess the level of benefit to be expected.

## Impact of the proposed legislation

Eliminating the need for various management plans (Strategic Asset, Drought, leakage) will reduce compliance related activities such as annual reports, audits and reviews. However we believe the production of such plans still represent "best trade practice" for a capable water service provider. We would still support a structure that retained an obligation to have such plans, removed the requirements for annual reports, audits and reviews, but retains a broad power for DEWS to requisition a provider if the plans were considered to be manifestly inadequate or outdated.

Removal of the requirement to produce Water Usage Advices for tenants of properties is viewed favourably by Cairns Regional Council. The production of these notices is expensive and largely ineffective in our experience especially in areas not serviced by Australia Post.

Allowing works to be conducted by unlicensed plumbers is supported but needs to be fully understood by organisations given that the responsibility for any risk to public health still rests with the organisation selecting and employing such staff as outlined in s45.

## **Alternatives or Changes Recommended**

Cairns Regional Council Water and Waste recommends investigating the extension of section 53CLA - Functions of a water connection officer to 53DNH - Recovery of costs of water connection compliance action from being SEQ specific to applying to all of Queensland as this would also align with the Plumbing and Drainage Act 2002.
