

I wish to make a submission regarding the Planning (Social Impact and Community Benefit) and Other Legislation Amendment Bill 2025.

I'm not a particularly articulate person, so please bear with me.

- 1) If the proposed developments were in the best interest of Queenslanders, they would pass existing legislative requirements.
- 2) The current legislation you want to bypass is in place for a reason. They don't exist just to annoy you. They are there to help mitigate issues or stop risky or inappropriate proposals. They are in place to protect Queensland. Bypassing these safeguards will lead to suboptimal solutions.

Green space can't just be recreated. Once it's gone it's almost impossible to get back. It is also next to a hospital. The construction will have a huge impact on their operations and can you imagine the traffic chaos on game days? "Sorry you weren't able to make it to the hospital in time, the cricket was on."

I also can't even fathom the idea of destroying a culturally important, indigenous site for the Olympics. It's beyond offensive.

4) A temporary solution at the old QEII site would be a great idea. The temporary facilities at the Gold Coast Commonwealth Games were amazing. Purpose built, used for 2 weeks, then dismantled and given to sporting clubs, schools, community groups. It was brilliant, and a great boost to the city without permanently sidling it with expensive facilities that are a financial drain on the state government or local council.

The opening and closing ceremony at a refurbished and expanded Suncorp Stadium would work great, while the track and field could be at QEII.

Other than the opening and closing ceremonies, the stadium is unlikely to need a huge capacity during the track and field events.

5) Utilising existing stadiums would be best, but if you have to build a giant white elephant

why not on top of the old Go Print site, directly next to the train station. Don't have to demolish the school then, you can build it while still using the existing Gabba, then demolish that when it's done.
