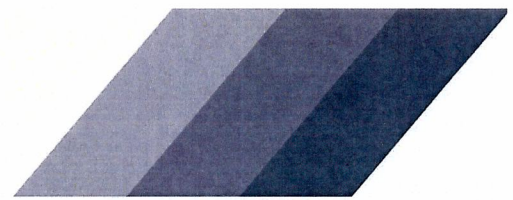
I was asked by the committee to provide further information on come points.
