## Inquiry

Increasing penalties for breaches of animal cruelty:

The current legislation measures for animal care and protection are out of date. It isn't helping animal welfare as much as it should, and the penalties to offenders are nowhere near harsh enough to stop and deter these people from repeating these cruel acts.

The sheer number of people who commit animal cruelty and animal neglect is a disgrace. It is obvious the measures put in place to protect animals are failing them; the penalties are way too lenient and do not discourage these people from committing these acts repeatedly.

I have seen and read way too many times of people committing horrible acts of cruelty to innocent animals, and all the court will do is let these people off with a slap on the wrist, small fines, or suspended jail sentences. How will people take their crimes seriously if they are not being made to think about their actions and have serious consequences to prevent these people from repeating their acts. I'll give an example of a terrible act of cruelty that should have been given a harsher punishment.

On the 13<sup>th</sup> of February 2019, a man in Mackay was court red-handed on camera in broad daylight, viciously beating a clearly friendly and unprovoked dog just because he felt like it. The court banned this man from owning animals for three years, and he was given 18 months' probation with 100 hours of community service for his crime.
