Where the changes need to be made

- Anonymous complaints should be stopped and replaced with confidentiality because the system provides easy delivery of anonymous complaints which encourages vexatious complaints
- Complaints of Conflict of Interest need to scaled to those of a genuine concern. Having coffee chats with residents who are in different groups that may have made a submission on a DA should not be reason to declare COI. An active networking councillor who may hold BBQ's at their house to support networking can be brought into a complaint for not declaring a COI.
- We need ICAC. It has to be independent, not an arm of government.
- The OIA is under a lot of pressure to go back to pre Balcarra day, and do nothing. The OIA need to be protected by powerful business lobbyists who are very motivated by investments
- The OIA has to be protected from being hung out to dry when they badly need assistance to investigate corruption which is easy to see and very difficult to prove
- OIA needs more power, not less

What the OIA has got right:

- ✓ Before OIA rolled out, the CCC investigated less than 2% of emails and acted on none which was evidenced by MP Rob Pyne when he delivered a box of complaints to Parliament to investigate various Councils
- ✓ Balcarra Report identified corruption could easily operate under the radar
- ✓ Council behaviour is now on notice and we have measures in place.
- ✓ The OIA has brought behaviour and accountability into the legal framework of a Councillor role
- ✓ The OIA acted strongly and swiftly which was needed due to the absence or non-recognition of authority or other controlling systems.
- ✓ The OIA strong actions gave citizens reason to respect Councils and a platform to be heard.
- ✓ The OIA is a strong voice for the people and it would be an injustice to take this away or weaken it
