If the fraudulently used the licence of to construct our house without our knowledge as we were contracting and Licence lending.  BSA lic no. This should be seen and dealt with by the BSA and Police as it is a criminal matter and Licence lending.
THE BUILDER DID NOT SUPPLT AND WRITTEN VARIATIONS
did not supply any variations – written or verbal – cost or construction wise! Supplied is a copy of all requests for payment or monetary matters which we have received from from signing the contract to today's date. As in evidence by site meetings by and there is a large amount of incomplete work on our house and we have even paid an extra \$42356.89 on top of the contracted sum.
THE BUILDER FRAUDULENTY USED SOMEBODY ELSE'S LICENCE NUMBER

THE BUILDER FAILED TO COMPLETE BUILDING OUR HOME
There is evidence of this failure by site meetings by and and and the decision by Member Oliver of the CCT that there are many parts of our house which are unfinished or even not started.
THE BUILDER USED THREATENING BEHAVIOUR
Supplied are statutory declarations by and and in regards to threatening behaviour for pressure to pay vague invoices with no variations. These include threats of caveats and foreclosure.
THE BUILDER SMOKED DRUGS ON SITE
Supplied are statutory declarations from, and and that smoking of drugs on site was a daily occurrence.
THE BUILDER DID NOT CONSTRUCT BY FOLLOWING THE PLANS
As evidence from Member decision from the CCT, that we the wardrobes and cupboards throughout the house have not been constructed as per the plans and also the front entrance has not been constructed as per the plans. These are all without any variations to design, contract or price. All of which we did not agree or have the opportunity to consider these changes to the plan.
THE BUILDER COMMITTED NUMEROUS OFFENCES UNDER THE DBC AND BSA ACT

## THE CONSTRUCT TIME HAS GONE WELL OVER WITH NO TIME VARIATIONS AND IS STILL INCOMPLETE

The construction of our house is still ongoing 7.5 years after starting the construction with a 156 day contract to final with no variations to time delays.

ADDITIONAL BREACHES
Upon checking a Licence Search on your website for, I have noticed that the amount of jobs and dollar valve for the years is incorrect and I have further information on many more jobs that had completed over the years and have not been listed with the BSA.
These jobs more than likely would not have had insurances, potable long service levies paid nor have any legal contracts written for these jobs.
