

# ESTIMATES COMMITTEE F - 2002 REPORT

#### INTRODUCTION

Estimates Committee F was appointed on 18 April 2002 to examine and report on the proposed expenditure set out in the Appropriation Bill for the organisational units within the portfolios of:

- Minister for Transport and Minister for Main Roads
- Minister for Public Works and Minister for Housing
- Minister for Innovation and Information Economy

The committee considered the estimates by examining the budget papers and ministerial portfolio statements, answers to pre-hearing questions on notice, evidence taken at a public hearing and answers to questions taken on notice at the hearing.

During the inquiry the committee examined a wide range of issues, which are listed in this report. For details on these issues the committee directs readers to:

#### TRANSPORT AND MAIN ROADS

The Transport and Main Roads Portfolio comprises the Department of Transport (Queensland Transport), the Department of Main Roads and government-owned corporations (GOCs), statutory authorities and other units that report to the minister through these departments.

# **Estimates Committee F Dissenting Report**

# **Transport and Main Roads**

Mr Chairman,

It is with regret that I find it necessary to provide this dissenting report in relation to the Report of Estimates Committee F in relation to the examination of the expenditure of the Department of Transport and Main Roads and associated entities.

I wish to state at the outset that it is not my usual practice to submit a dissenting report as I am of the belief that the Government should be supported in legitimate expenditure towards the achievement of its policy goals. This year, however, I am at odds with not only the Government's policy goals for the portfolios of Transport and Main Roads, but also the manner in which the Minister for Transport and Main Roads has administered expenditure of these portfolios budgetary allocations and unwillingness to submit to proper scrutiny through the Estimates Committee process.

I have detailed my concerns under separate headings listed below.

### **Avoidance of proper scrutiny under the Estimates Committee process:**

My broad concerns under this heading relate to what I consider to be the failure of the Minister to provide the Committee with the necessary information to permit the appropriate scrutiny of the operations of the Departments and GOC's. Both the structure of the budget documentation and his responses to Questions on Notice and Questions without Notice were calculated to avoid accountability and prevent the Committee from being able to determine if taxpayers' funds are being properly acquitted.

In support of my conclusion I would refer you to the following issues:

• The Minister refused to provide the complete details in relation to my first two Questions on Notice on the basis that the compilation of the information would divert departmental resources from essential services.

During hearings the Minister claimed that this situation arose because the information requested was too broad, yet in the past specific requests for information has been denied because they were too narrow.

The two questions concerned were as follows:

# "Question 1:

In regard to all Promotional, Public Awareness and Advertising expenditure of, or administration by your departments for the 2001/2002 financial year, could you please specify:

- a) The campaign title and purpose;
- b) The expenditure of each of (a);
- c) The location of the region of (a) and (b);
- d) The number of persons employed to service promotional, public relations and advertising needs in your department as well as any associated agency or instrumentality; and
- e) Did the Premier or Minister's photo appear in this material, if so how many times? and

# Question 2:

With regard to departmental activities such as reviews undertaken, taskforce investigations, realignments, re-structures, steering committees, working parties, interdepartmental working groups and pilot programs, please provide details of:

- a) The duration of the exercise
- b) Staff allocations for each activity including details of staff classifications
- c) The terms of reference for each activity
- d) The time lines for each activity
- e) Detailed listings of significant milestones related to the development of such activities and;
- f) Details of any implementation of any recommendations made / proposed as a result of such activities?"

I noted with some interest that the Minister was able to provide some information during the hearing in response to direct questioning as to whether Cutting Edge Post Pty Ltd had been involved in the preparation of any such material forming the subject of my first two Questions on Notice.

Although the Minister's responses to my Questions without Notice concerning Cutting Edge Post Pty Ltd were less than impressive and in my view designed to avoid provide a complete response, they do indicate that he had been briefed with some information that he clearly was unwilling to provide to me unless prompted to do so, despite my earlier Questions on Notice.

• I made repeated requests of the Minister during the hearings for detailed information as to the results of an audit undertaken of bridges under the Bridge Asset Management System referred to in the Ministerial Program Statement (page 2-15).

The Minister repeatedly avoiding providing this information to the Committee, but this information reported in *The Courier~Mail* the very next morning.

# Serious failure in financial management:

This issues I wish to highlight in relation to this heading also has relevance as an example of the Minister's propensity to avoid accountability in relation to providing full and detailed information to

the Committee. However, in this context, I am concerned as to the extent of gross mismanagement and reporting of Queensland Transport's capital expenditure

• During the hearing the Minister claimed to be unable to respond to a question comparing budget allocations in last year's capital statement to actual expenditure reported in the budget documents being examined for 2002/03.

Part of the Minister's difficulty appeared to be as a result of what I can only construe as being a deliberate attempt to disguise an obvious 'under spend' by inexplicably breaking up Transport Portfolio allocations in the Capital Statement. This practice of changing reporting structures is by itself an example to the Beattie Government trying to evade scrutiny.

Although the Minister eventually conceded the Department of Transport had in fact underspent last year's capital budget allocation in excess of \$175 million, he did so at the very close of the hearing again denying the committee an opportunity of follow up questions.

• In response to another Question on Notice the Minister advised that stopping patterns and fare structures in relation to the Cairns Tilt Train were not available and would be the subject of an extensive consultation process which the Government was yet to undertake.

The Minister repeated this claim before the Committee at the hearing, but once again this information was readily available to *The Cairns Post* within two days and clearly indicates a number of basic assumptions used to justify this project including the transit time, fares, number of services were available to the Minister

I can only conclude that the Minister deliberately was less than frank in the provision of this information to the Committee as part of a deliberate action to avoid testing questions on the subject that would embarrass him and the Beattie Government over its mismanagement of this project.

Contrary to the recommendations of the Parliamentary Public Works Committee, the Cairns Tilt Train project continues without appropriate financial analysis and with the real costs being hidden from public scrutiny by artifice.

Further example of the Beattie Government's contemptuous treatment of the Estimates Committee process is recorded in Hansard. Briefly, other issues include:

- Evidence that capital expenditure has been significantly reduced and a large number of jobs will be lost from Queensland Railways and Main Roads in particular;
- Ineptitude in the administration of major construction projects have resulted in a massive underspend by Queensland Transport costing the Queensland community, on the Minister's own calculations, more than 3,000 jobs last year at a time when Queensland continues to record the worst unemployment rate in mainland Australia;
- The Department of Main Roads continues its sorry record of massive budget blow outs while important projects are delayed as expenditure is slipped from budget to budget.

The mystery of the Tugun Bypass deepens with the Minister being unable to specify the anticipated cost of the project while stripping \$2 million from the promised allocations for this financial year.

It is again worthy of note that the Beattie Government has still to deliver on any major infrastructure project of its own making for over four years.

Meanwhile South East Queensland is being strangled by the Beattie Government's failure to address integrated public transport and further delays to the implementation of integrated ticketing.

In view of the issues raised, I regret to inform the Committee that the Opposition must dissent from any report endorsing the Beattie Government's proposed expenditure for the Department of Transport and Main Roads and associated entities.
