

ESTIMATES COMMITTEE G - 2004 REPORT

Introduction

- 1. The sessional orders adopted by the Legislative Assembly on 20 May 2004 established seven estimates committees to consider proposed expenditure under the *Appropriation Bill 2004* and the *Appropriation (Parliament) Bill 2004*.
- 2. Estimates Committee G was appointed to examine and report on the proposed expenditure set out in the *Appropriation Bill 2004* for the organisational units within the portfolios of the Minister for Natural Resources, Mines and Energy, and the Minister for Primary Industries and Fisheries.
- 3. The committee conducted a public hearing on Friday, 23 July 2004 to take evidence from these Ministers and their officers.
- 4. For the purpose of examining the proposed expenditure for the organisational units allocated to it, the committee considered information obtained at the public hearing in conjunction with:
 - budget papers and Ministerial Portfolio Statements (MPS) tabled by the Treasurer;
 - written responses provided by Ministers to questions on notice prior to the public hearing; and
 - Ministers' written answers to questions taken on notice at the public hearing.
- 5. Accompanying this report is a volume of "Additional Information" presented by the committee to the Legislative Assembly. The additional information includes the minutes

- of the committee's meetings, documents tabled at the hearing and answers to questions on notices before and during the public hearing.

STATEMENT OF RESERVATIONS

The process of Estimates Committee hearings in relation to the Ministerial Program Statement for the Department of Natural Resources, Mines and Energy highlights yet again the weaknesses in the operations of Estimates Committees in Queensland as a mechanism for scrutinizing expenditures by government Departments.

These weaknesses include

- The limit on the number of Questions on Notice able to be asked as part of the Estimates process.
- The receipt of replies to such Questions on Notice less than 24 hours prior to the actual hearing meeting of the Committee.
- The limited time available for the conduct of hearings for each Department thus limiting the capacity of the Parliament to explore issues of concern to finality.
- The limit on each questioning session generally to 25 minutes thus inhibiting the capacity to pursue issues of interest until finality is reached.
- The use by Ministers and Government Members of questions to provide a basis for propaganda statements rather than genuinely exploring issues relating to Departmental Expenditures.
- The failure of Ministerial Program Statements to contain comprehensive, consistent and readily understandable performance standards that are consistently applied on a year by year basis.
- The Grouping of inappropriate activities in programs and subprograms that inhibit capacity to explore individual activities by government.
- The failure to permit statutorily independent officers and organizations to be directly responsible to and answer questions directly by Members of Parliament thus undermining their independence from Executive government.
- The use and placement of Departmental Displays behind Estimates
 Committees reflecting a lack of impartiality in Committee processes and a
 denial of the capacity of Non-government members to utilise similar
 opportunities.

In addition to these general comments about the Estimates Committee process the hearings of Estimates Committee G on 23 July 2004 also highlighted the following matters on which the response of the Minister was unsatisfactory:

- The failure of the Beattie Government to provide sufficient funding to improve the State's geological database.
- The failure of the Beattie Government to commit significant funding towards the development of clean coal technology.
- The Minister's continued refusal to provide a proper explanation of the funding arrangements for the Townsville Power Station, and why unspecified amounts of taxpayers' money are being spent to meet a selfimposed gas usage target that will not meet the needs of local industry.
- The failure of the Beattie Government to properly compensate landholders adversely affected by vegetation management restrictions introduced since 1999.
- The Minister's refusal to guarantee that landholders unable to develop the land they currently own will be able to access the State Government's financial assistance package to buy new land that can be developed.
- The Minister's failure to prevent a blow-out in the completion timeframes for water resource planning throughout Queensland.

The process of Estimates Committee hearings in relation to the Ministerial Program Statement for the Department of Primary Industries and Fisheries highlights yet again the weaknesses in the operations of Estimates Committees in Queensland as a mechanism for scrutinizing expenditures by government Departments.

- The Grouping of inappropriate activities in programs and subprograms that inhibit capacity to explore individual activities by government.
- The failure to permit statutorily independent officers and organizations to be directly responsible to and answer questions directly by Members of Parliament thus undermining their independence from Executive government.
- The use and placement of Departmental Displays behind Estimates
 Committees reflecting a lack of impartiality in Committee processes and a
 denial of the capacity of Non-government members to utilise similar
 opportunities.

In addition to these general comments about the Estimates Committee process the hearings of Estimates Committee G on 23 July 2004 also highlighted the following matters on which the response of the Minister was unsatisfactory:

- The failure of the Minister to properly explain why more than \$1.2 million of Farmbis funding was spent training 350 divers in the Torres Strait.
- The Minister's refusal to properly account for almost \$2 million in unspent FarmBis funds.
- The failure to explain why 25% of Farmbis funding was spent in just three Shires in Far North Queensland, mainly in the Cook Electorate.
- The Minister's refusal to clarify how dive courses were funded when the Farmbis guidelines clearly state that activities that are NOT supported are:
 - 1. Stand alone technical or operational training activities and
 - 2. Specific training activities required to be undertaken to satisfy government regulations and statutory obligations. The Minister even stated that these courses were focussed on Workplace Health & Safety issues.
- The Minister's refusal to provide copies of local drought committees' minutes to the Estimates Committee.
- The Minister's refusal to provide any financial support to beef producers to assist with the implementation of the National Livestock Identification Scheme and just \$690,000 in infrastructure spending to assist abattoirs and sale yards. Answers by the Minister showed only \$690,000 of direct funds to NLIS with other monies being for tasks such as brands, cattle and property identification all of which have been normal DPI tasks and costs for many years. Thus the \$4.45 million announced by the Minister for NLIS Identification in Queensland is misleading and incorrect.
- The Minister's refusal to provide structural adjustment assistance to commercial fishers affected by State Government fishing restrictions, such as the coral reef fin fish management plan.
- The failure of the Minister to allocate significant funding to assist the sugar industry, with only identified spending of \$1.7 million for the Future Cane project.
- The Minister's refusal to provide projections for spending and uptake of the Farm Consolidation Loan Scheme.
- The Minister's pre-empting of the Estimates Committee hearing process by releasing the answer to a Non-Government Member's Question On Notice relating to fishing two days before the hearing.
