### NOTICE OF MOTION

### (Notice given 28 October 1997)

1 **MS BLIGH** to move – That this Parliament recognises the right of students of East Brisbane State School to be educated in an environment which facilitates and encourages their physical, social, cultural and emotional development.

#### The Parliament—

- calls on the Minister for Education to guarantee that no approvals are given for the Brisbane Cricket Ground Trust to resume more East Brisbane State School land for Trust development until an independent mediator is appointed and a mutually agreeable outcome achieved for all parties; and
- calls on the Treasurer to ensure the Brisbane Cricket Ground Trust considers all possible redevelopment options, including—
  - (1) the relocation of the 800 seat function room;
  - (2) the redevelopment of other parts of the cricket ground, including the old police station site and the Brisbane City Council park, to deliver greater seating capacity without such a major impact on the school;
  - (3) an appropriate package for the redevelopment of the school's facilities, including classrooms, the library and playing space, to compensate for the imposition of the redevelopment on the school community; and
  - (4) a focus on the safety issues of children, both during and after construction.

### 1344 MR BEATTIE ASKED THE PREMIER (MR BORBIDGE)—

With reference to his statement to Parliament earlier this week concerning Queensland's bid for the 2002 Expo to be held at the Gold Coast and particularly to his breast beating about the fact that he has taken on the Prime Minister and insisted that Australia be represented at Expo 2000 in Hanover as a crucial part of Queensland's push to hold the 2002 Expo, and given that Australia's participation in Expo 2000 in Hanover is deemed vital to our case—

- (1) Why has he not equally insisted that the Howard Government's fiscal constraints be overturned in relation to the 1998 Expo in Lisbon?
- (2) Given that our main competitor for 2002 Expo, namely the Philippines, will be represented both in Lisbon and Hanover, isn't it essential that Australia and Queensland be seen to support both Expos due before 2002?
- (3) When will he and the Prime Minister get professional in regard to Queensland's bid for Expo 2002 and ensure that funds are available to mount a major Australian presence at Expo 1998 in Lisbon and Expo 2000 in Hanover?

# 1345 **MR GIBBS** ASKED THE MINISTER FOR TOURISM, SMALL BUSINESS AND INDUSTRY (MR DAVIDSON)—

With reference to the presence on the Board of Directors of the Silicon Studio Training Centre of a senior public servant of his department—

(1) Who is this public servant, what is his official Queensland Government position and classification, who appointed him to this directorship and why?

- (2) If he wasn't appointed officially, when was the Minister or his Chief Executive Officer alerted to this officer's acceptance of a directorship of this company, by what means and will he table the relevant document; if not, why not?
- (3) Is he aware that such notification is a requirement of a 'public official' as set out in the *Public Service Ethics Act 1994* and could he give a guarantee that no conflict of interest has occurred between this officer's Government role and that of his directorship of this company?
- (4) What role did this officer play in securing the \$2m of Government training funding for this company and, particularly, in justifying the size of the \$10,000 per trainee Government scholarship and what portion of the \$2m going to the Silicon Studio Training Centre by way of training assistance is coming from DEETYA?
- (5) Is this officer aware of the substantial discrepancy between what Silicon Studio Training Centre, of which he is a director, receives for each trainee it puts through its course as compared to what they charge a paying student and what remuneration is this officer receiving for his role as a Director of Silicon Studio Training Centre?

# 1346 **MR ROBERTSON** ASKED THE MINISTER FOR TRAINING AND INDUSTRIAL RELATIONS (MR SANTORO)—

With reference to recently released figures from the Department of Employment, Education and Youth Affairs that show that between June 1996 and June 1997, unemployment in Runcorn increased from 7.3 per cent to 9 per cent, in Stretton from 10.3 per cent to 11.8 per cent, in Sunnybank from 6.5 per cent to 7 per cent and in Calamvale from 8.3 per cent to 9.1 per cent—

- (1) What specific employment creation programs are in place that will alleviate these unacceptably high levels of unemployment in these suburbs?
- (2) When will unemployment in these suburbs begin to decline?
- (3) What is the target unemployment rate set by the Government and when does he expect to achieve this level?
- (4) Why has unemployment in these suburbs continued to increase under this Government?
- (5) What immediate action is he prepared to take to address the escalating unemployment rate in these suburbs?

# 1347 **MR HAMILL** ASKED THE DEPUTY PREMIER, TREASURER AND MINISTER FOR THE ARTS (MRS SHELDON)—

With reference to the Statements of Appropriation contained within the various departmental annual reports which generally do not clearly identify the current or capital nature of carry—overs and further, as certain departments are yet to furnish their annual reports for 1996–97, and to the Treasurer's Annual Statement for 1996–97 in which I note that in respect of the Consolidated Fund, \$469.169m was carried over to the 1997–98 Budget—

How much of this carry-over was in respect of capital, and how much was current expenditure?

# 1348 **MR MULHERIN** ASKED THE MINISTER FOR MINES AND ENERGY (MR GILMORE)—

With reference to the current coal gasification study being undertaken at Pinjarra Hills near Kenmore—

- (1) What is the total budget for this work, over what timeframe will it run and what amount is the Queensland Government contributing to it?
- (2) Is the remainder coming from the Federal Government, or are there other funding sources?

- (3) How many scientists are employed full-time on the project and at what classification?
- (4) As Italy, Spain and the USA are already well advanced with this technology, why is Queensland undertaking further studies here, i.e., why don't we benefit from this overseas expertise and simply implement the technology?
- (5) With Queensland's and Papua New Guinea's abundant resources of cheap natural gas, why are we spending scarce research funds on coal gasification technology?
- (6) Is there a private gas consortium involved with this coal gasification work at Kenmore; if so, who is it?
- (7) Does he see coal gasification leading to a reduction in the overall volume of coal Queensland burns or exports?

# 1349 **MR J SULLIVAN** ASKED THE MINISTER FOR POLICE AND CORRECTIVE SERVICES AND MINISTER FOR RACING (MR COOPER)—

With reference to s 127 of the *Police Powers and Responsibilities Act 1997* (Power to use force against individuals in critical situations) and his assertion (*Hansard*, page 4427) that "the provisions of this clause take from the Criminal Code what is provided for under the law of the Criminal Code, but they do not extend it" (emphasis added)—

Which provisions of the Criminal Code provide for the range of powers included in s127 of the *Police Powers and Responsibilities Act 1997*?

#### 1350 MR Mcelligott asked the premier (MR Borbidge)—

With reference to advertisements headlined "The Big Turnaround" which misrepresents the history of the financial position of the workers' compensation scheme in that Labor revealed a year ago that a top secret State Cabinet submission had admitted the fund could become fully solvent even with the retention of common law claims and without changing the Labor Government's legislation—

- (1) How much of the public's money has been spent on creating this advertisement?
- (2) How much has been spent on placing this advertisement in newspapers and magazines?
- (3) How much more will be spent on placing it?

# 1351 **MR ELDER** ASKED THE MINISTER FOR TRANSPORT AND MAIN ROADS (MR JOHNSON)—

- (1) What was the source of projections for vehicle movements on which he based his decisions in relation to the Pacific Motorway and the South east Transit Project?
- (2) In particular, does he still accept the projections for future vehicle movements set out at page 12 of Volume 1 of the Impact Management Plan for the Pacific Motorway and page 15 of Volume 2?
- (3) How does he explain the discrepancies between those figures and the figures he used in answering Question on Notice No. 280 in May 1996?
- (4) What was the source of the claims by his project director, Bob Higgins, in his disgraceful television advertising campaign on the Pacific Motorway, that there are currently 85,000 vehicles a day on the road and that will double by 2015 and which point on the highway is he referring to?
- (5) What assumptions has his department made for the percentage of vehicles on the highway south of Brisbane that will proceed on into the Brisbane City area?
- (6) Does he have traffic figures and projections for vehicles (as opposed to person trips) for major points between Brisbane and the Gold Coast that are agreed between the Department of Transport and the Department of Main Roads?
- (7) What are the existing traffic flows and projections for 2005 and 2011 and/or 2015 for major points along the highway north of the Logan River?

### 1352 MR HAYWARD ASKED THE PREMIER (MR BORBIDGE)—

With reference to television advertisements featuring the rail link to the Gold Coast, the public hospital system, South Bank, the main road between Brisbane and the Gold Coast and the alleged reduction in Government red tape—

- (1) How much taxpayers' money was spent on having the advertisements made?
- (2) How much has been spent so far on putting them to air?
- (3) How much more has been budgeted on putting them to air?

# 1353 **MR BRISKEY** ASKED THE MINISTER FOR POLICE AND CORRECTIVE SERVICES AND MINISTER FOR RACING (MR COOPER)—

With reference to claims by the then head of the CJC Paedophilia Inquiry, Bob Mulholland QC, that CJC investigators were being hampered because former and serving police were not reporting incidences of police cover—ups of the crime—

- (1) Is he aware of any incidence of a former or current police officer not reporting and/or acting upon any paedophilia activity in Queensland?
- (2) Does he agree with Mr Mulholland's assertions on this matter; if not, why not?
- (3) What is he doing to ensure cover–ups of this nature are not occurring in the Queensland Police Service?

### 1354 MRS LAVARCH ASKED THE MINISTER FOR HEALTH (MR HORAN)-

- (1) Have staff at the Maroochydore Mental Health Clinic been directed not to issue pathology request forms for patients needing regular blood tests for monitoring of drug levels and that patients now have to attend local general practitioners to obtain the necessary pathology request forms?
- (2) Has any consideration been given to the impact of this increased cost for chronically ill patients?
- (3) Has this system been introduced Statewide or only on the Sunshine Coast?
- (4) Is he aware that the cost of the GP visit is approximately twice the average cost of the required test?
- (5) Has this change resulted from consultation with Mental Health Services?
- (6) As the nearest public pathology facility to the Sunshine Coast is at Nambour Hospital, is this action intended to encourage patients to attend local general practitioners to obtain the necessary pathology request forms, thereby moving some of the cost on to the federal health system?

# 1355 **MR DOLLIN** ASKED THE MINISTER FOR EMERGENCY SERVICES AND MINISTER FOR SPORT (MR VEIVERS)—

With reference to my previous Question on Notice of 26 March asking whether he and the Government would honour the commitment made by the previous Labor Government to provide \$1m towards a community recreation centre in Maryborough which would be geared towards youth activities and as proposals for the construction of a Maryborough community youth recreation centre were presented to his department in November 1995, February 1996, September 1996 and I made representation again in October 1996 and February 1997 on the steering committee's behalf and the proposal was supported by the previous Government and a press release from his office on 9 April stated that he would honour commitments made by the previous Government—

Will he now make a commitment as promised to provide \$1m towards a community recreation centre for Maryborough youth?

# 1356 **MR PEARCE** ASKED THE MINISTER FOR POLICE AND CORRECTIVE SERVICES AND MINISTER FOR RACING (MR COOPER)—

With reference to ATSIC Central Queensland Regional Council legal advice that it could no longer fund the Woorabinda Aboriginal Community Police positions—

Given that Woorabinda Aboriginal Council currently funds four of the twelve Aboriginal Community Police positions, what is the Queensland Police Service doing to assist the council in funding the other eight positions so as to maintain law and order under what has proved to be a successful community policing program?

# 1357 **MR DE LACY** ASKED THE DEPUTY PREMIER, TREASURER AND MINISTER FOR THE ARTS (MRS SHELDON)—

With reference to the State Government subsidy paid to American producers of the film "The Thin Red Line" shot earlier this year in and around Cairns—

- (1) What was the total value of this subsidy and is this the highest amount paid by the Queensland Government to an overseas film production?
- (2) Why were local production firms bypassed in preference to Sydney and Adelaide crews with little of the \$65m production costs of this film going to the local film industry?
- (3) Does she believe the Pacific Film and Television Commission has a responsibility to promote local film expertise as well as locations, if we are to maximise the benefit from State Government subsidies in developing a viable long term film industry in this State?
- (4) Is she aware that the perception exists in local film industry circles that Village Roadshow exerts an undue influence over decision making by the Pacific Film and Television Commission with southern crews and companies associated with them invariably gaining preference for local work?
- (5) Is she also aware that staff of the Pacific Film and Television Commission refer to local film industry companies and individuals as 'basket weavers'; if so, what does she intend to do to correct this extraordinary bias?

# 1358 **MR MILLINER** ASKED THE MINISTER FOR TOURISM, SMALL BUSINESS AND INDUSTRY (MR DAVIDSON)—

With reference to his plans to establish rhinoparks at two locations in North Queensland—

- (1) Did he or his department recently present Burke Shire with a grant of the order of \$20,000; if so, what was it for and how many similar grants has Burke Shire received previously from him or his department?
- (2) Was an agreement reached with Burke Shire at that time that they would exempt any rhinopark application in their shire from normal development approval requirements, particularly environmental?
- (3) Has the previous Chief Executive officer of Burke Shire, a Mr Jack Garside, been sacked by Burke Shire and was Mr Garside a strong advocate of the rhinopark proposal for the shire, so much so that he spent time with its principal proponent, a Mr George McFarland, at his Noosa office of Sanctuary Park?
- (4) Is there any possibility that Mr Garside, the former Mayor of Burke Shire, Mr Moloney, and the owner of Beamesbrook Station, Mr John Nelson are actively promoting the rhinopark idea in Burke Shire in private capacities?
- (5) Are both Croydon and Mt Isa Councils also negotiating with Mr McFarland as possible sites for rhinoparks?
- (6) When will the pre-feasibility study report undertaken by James Cook University staff be finalised and will he be tabling it in the Parliament?

# 1359 **MR SCHWARTEN** ASKED THE MINISTER FOR NATURAL RESOURCES (MR HOBBS)—

With reference to the Marcus Shore high dunes—

(1) Is he aware that in 1993, the Department of Environment advised that the "Conservation significance of this area cannot be overstressed"?

- (2) Does he acknowledge the conservation significance of this last piece of native high dune vegetation in south–east Queensland?
- (3) Does he acknowledge that the conservation significance of this area might justify its inclusion in the Noosa National Park?
- (4) Why has he, for the Department of Lands, lodged an objection to the listing of this area in the Register of the National Estates?
- (5) Does he acknowledge that the local community in this area overwhelmingly wish the Marcus Shore high dunes to be protected from development and why is he ignoring the interests of this community?

# 1360 **MR NUTTALL** ASKED THE MINISTER FOR TOURISM, SMALL BUSINESS AND INDUSTRY (MR DAVIDSON)—

With reference to the television advertisment featuring what is alleged to be a reduction in red tape—

- (1) How much of taxpayers' money was spent on having the advertisement made?
- (2) How much has been spent so far on putting it to air?
- (3) How much more has been budgeted on putting it to air?

### 1361 MS SPENCE ASKED THE MINISTER FOR ENVIRONMENT (MR LITTLEPROUD)—

With reference to his recent press release in which he admitted the Department of Environment had financed and built a large shed on national park land at Orchid Beach on Fraser Island for community use—

- (1) Is this true; if so, at what taxpayer expense was this shed built, what precedent is there for public funds to be spent in this way and from which area of the department budget were these funds drawn?
- (2) If these funds were drawn from the recreation area management fees collected from visitors to the island, how does he justify using these funds to provide local community facilities rather than improving visitor facilities on the island?
- (3) Is it true that aside from the State Emergency Service and the Rural Fire Brigade that organisers of the Toyota Fishing Classic will have use of the shed as a bar and storage area during the week long fishing competition and aircraft using the supposedly soon to be opened airstrip will also have access to the shed for storage purposes?
- (4) Will the Department of Environment be recouping its investment in this shed once the Hervey Bay City Council assumes responsibility for the head lease or when the sublease issues to the Orchid Beach residents' group; if so, when is this anticipated to occur and who actually will be repaying these moneys?
- (5) Were tenders called for construction of the shed; if not, why not, and who was the successful tenderer and what other plans does he have to build community facilities on our national parks at taxpayer expense?

# 1362 **MR ROBERTS** ASKED THE MINISTER FOR TRANSPORT AND MAIN ROADS (MR JOHNSON)—

With reference to the Newman Road level-crossing adjacent to the Geebung Railway Station-

- (1) What plans does Queensland Rail have regarding future upgrades to this level-crossing?
- (2) Will he initiate an investigation into improving this railway crossing by (a) examining the options of either constructing an overpass or installing an additional level–crossing connecting Robinson Road East and West and (b) examining the impacts of these proposals on (i) traffic flow in and around the Geebung shopping centre and local residential areas and (ii) local residents and businesses?

# 1363 **MR D'ARCY** ASKED THE MINISTER FOR POLICE AND CORRECTIVE SERVICES AND MINISTER FOR RACING (MR COOPER)—

With reference to a robbery reported to police, which took place at 119 Aquarius Drive, Kingston on 22 October—

- (1) What was the police response time for investigating this incident?
- (2) What is the average response time for police investigation of crime in Logan City?
- (3) Why was the gentleman from 119 Aquarius Drive told that he would have to wait anywhere from 3 days to 3 weeks for police to investigate the theft of items from his residence?

### 1364 MR FOURAS ASKED THE MINISTER FOR MINES AND ENERGY (MR GILMORE)-

With reference to the extension of mains power electrification into the Daintree region—

- (1) Why is he intent on wasting taxpayers' money to connect Australia's largest renewable energy community to the grid?
- (2) Is he aware that half of the landowners in the Daintree wish to sell their land back to the Government?
- (3) Is he aware that the cost of buying this land back, and conserving it, is less than or equivalent to the cost of supplying the Daintree with grid power?
- (4) Why does he wish to persist in using fossil fuels when new, more environmentally benign technology is more appropriate and Australia and the world are realising that solar energy is the way of the future?
- (5) Is he aware that the International Union for the Conservation of Nature have passed a motion opposing the proposed main power extension into the Daintree region on the grounds that it is considered to be in breach or contrary to the spirit of the World Heritage Convention affecting the Wet Tropics rainforest?
- (6) What costs have been incurred by (a) the department, (b) SEQEB and (c) any other Government agency in respect to this proposal since the change of Government in February 1996?

### 1365 MRS EDMOND ASKED THE MINISTER FOR HEALTH (MR HORAN)—

With reference to Queensland Health funding for the Young Parents Program under the Innovative Health Services for Homeless Youth Program and given that this program provides a valuable service to young mothers, preventing significant health problems on a shoe–string budget—

- (1) How does he explain his department's refusal to fund an administrative error which was made by his department and identified by his department?
- (2) Why should Young Parents Program have to reduce its service to pay for inefficiency on his part?

#### 1366 MR WELFORD ASKED THE MINISTER FOR ENVIRONMENT (MR LITTLEPROUD)—

With reference to the Port Hinchinbrook development—

- (1) Who performs the function as independent monitor of the environmental management requirement in the construction of the Port Hinchinbrook development at Oyster Point?
- (2) Has the independent monitor or any other person investigated the recent removal or destruction of approximately 40 mangroves adjacent towards the point; if not, why not?
- (3) What is the outcome of this investigation and who is responsible for the mangrove removal or destruction?
