#### 1 MEETING OF THE HOUSE

The House met at 9.30am pursuant to adjournment. The Speaker (Honourable R K Hollis) read prayers.

#### 2 PETITIONS

The following petitions, lodged with The Clerk by the Members indicated, were received-

Mr Baumann, from 4 petitioners, requesting the House to authorise the installation of directional and advisory signage to Sanctuary Cove/Hope Island from north and south bound traffic on the Pacific Highway.

Dr Clark, from 472 petitioners, requesting the House to instruct the Department of Main Roads to install traffic lights at the intersection of Harley Street and the Kamerunga-Brinsmead Road in Cairns, as soon as possible.

Mr Connor, from 1,565 petitioners, requesting the House to prevail upon the Minister for Transport and Minister for Main Roads, the Honourable Steve Bredhauer, to undertake the duplication of the Alexander Drive / Nielsens Road overpass on the Pacific Motorway at the earliest possible time, thus providing relief to the residents and motorists in this area.

#### 6 MATTER OF PRIVILEGE

Treasurer (Mr Hamill) rose on a matter of privilege and made the following statement-

'I rise on a matter of privilege. The member for Caloundra has quite falsely misrepresented statements I made in the House yesterday.

The member for Caloundra has quite disgracefully misrepresented statements I made in the House yesterday by falsely stating this morning that I criticised stockbroking firms involved with the Suncorp Metway sell down.

Let the record show that yesterday I stated quite clearly that I did not question in any way the professionalism or the integrity of the brokers concerned.

As I stated yesterday, in response to repeated interjections from the Opposition benches, those brokers were used by this Government in the sell down of the Queensland Government interest in the Bank of Queensland and the TAB. But there was an important difference. When we engaged brokers to do that work, there was no exclusive arrangement entered into, as the coalition had done with respect to the Suncorp sale. We sought expressions of interest in a competitive process and had a probity auditor undertake the review. No such thing occurred with respect to the very lucrative contract entered into by the then Treasurer, a contract that involved the payment of over \$600,000 in default of stage 2 of that contract.'.

#### 12 MATTER OF PRIVILEGE

Leader of the Opposition (Mr Borbidge) rose on a matter of privilege and made the following statement—

'I rise on a matter of privilege. This morning the Treasurer implied that during his answer to a question in this place yesterday he had not criticised a number of companies and individuals. My question related to Wilson HTM. A perusal of page 320 of yesterday's Hansard reveals that the Treasurer named Wilson HTM, Morgans, and Were and Sons. He then went on to talk about secret lobbying, secret and exclusive dealings and financial kickbacks. The Treasurer said—

"Sometime before 26 August 1996, representatives of stockbroking houses Wilson HTM, Morgans, and Were and Sons met with the then Treasurer and her Treasury officials to lobby secretly ..."

He went on to say-

I would like to know who benefited out of these secret and exclusive dealings. On whose authority was there no tender?"

He went on to say-

"The story doing the rounds down at Eagle Street was that one broker was able to purchase a new Porsche as a result of this deal ..."

He went on to say-

"There is also the issue of financial kickbacks."

Clearly, the Treasurer of this State has smeared those companies. He has smeared the principles of those companies under parliamentary privilege. He has done so falsely and in a cowardly fashion, and he should have the decency and the courtesy to publicly apologise.'.

#### 13 MATTER OF PRIVILEGE

Treasurer (Mr Hamill) rose on a matter of privilege and made the following statement-

'I rise on a matter of privilege. It is typical of the Leader of the Opposition to selectively quote from any document or any reference which he has before him. In addition to the issues raised and the reflections cast on me by the Leader of the Opposition, let me quote from the record those elements which are not convenient for the Leader of the Opposition to use in support of his assertions. I said—

"I am not questioning the capacity of these people to do the work. They have done good work for us, too. I am questioning why they – the former Government – let a contract without a tender."

I did not name the firm in question. It was the Opposition which made connections that one of the key elements made a \$35,000 donation to the Liberal Party following the awarding of this contract. Those are matters that are on the public record. This demonstrates the hypocrisy of the Leader of the Opposition. He casts aspersions on Peter Forster for attending a Labor Party function and claims that was special treatment when his own Government allowed exclusive dealings to occur, awarding multimillion-dollar contracts without any opportunity for any other people to participate in the contract process.'

#### 14 MATTER OF PRIVILEGE

Premier (Mr Beattie) rose on a matter of privilege and made the following statement-

'I rise on a matter of privilege. The Treasurer's position on this issue was very clear yesterday. It is only through the mischievous dishonesty of the Opposition and its reinterpretation of any matter that it does not want to agree with that we end up with a nonsense debate like this. The Leader of the Opposition could not tell the truth if his life depended on it. If we ever find the truth and the Leader of the Opposition in the one room at the same time, it will be an extraordinary day for Queensland. Let me make it clear: I stand by my Treasurer on this matter.'.

#### 15 MATTER OF PRIVILEGE

Leader of the Opposition (Mr Borbidge) rose on a matter of privilege and made the following statement—

'The Premier was not in the Chamber when I quoted the words of the Treasurer. If the Premier is in any doubt whatsoever that his Treasurer has smeared the good name and reputation of some of Brisbane's finest firms and finest business people, I refer him to page 320 of yesterday's Hansard.

What we have seen is a gutless Premier who will not discipline a Treasurer who has indulged in an act of massive political cowardice in an attempt to score some points off the most successful privatisation that this State has ever seen. The answers to the Treasurer's queries were more than appropriately responded to by the former Treasurer and the member for Caloundra this morning.

If the Treasurer had any decency whatsoever, he would get up in this place and apologise to those companies and those individuals for the very definite inference which was his answer yesterday and which is now on the public record in Hansard for all time.'.

### 18 STATEMENT BY SPEAKER - LIQUOR (TRADING LIMITATIONS ON ANZAC DAY) BILL

Mr Speaker made the following statement-

'Honourable Members—

I draw the attention of the House to the Liquor (Trading Limitations on Anzac Day) Amendment Bill 2000 introduced in the House this morning. This Bill has the same purpose as the Liquor Amendment Bill 1999, which was defeated on the second reading during this session of Parliament. Page 499 of *Erskine May* has this to say on matters already decided during the same session—

"There is no general rule or custom which restrains the presentation of two or more bills relating to the same subject, and containing similar provisions. But if a decision of the House has already been taken on one such bill, for example, if the bill has been given or refused a second reading, the other is not proceeded with if it contains substantially the same provisions; nor could such a bill be introduced on a motion for leave ..."

Our own Standing Order 76 has this to say on the matter in question-

"A Question or Amendment shall not be proposed which is the same in substance as any Question which, during the same Session, has been resolved in the Affirmative or Negative.".'.

*Speaker's ruling:* Mr Speaker ruled that the Liquor (Trading Limitations on Anzac Day) Amendment Bill was out of order.

#### 19 POLICE POWERS AND RESPONSIBILITIES BILL

Order of the day read for the adjourned debate on the motion of the Minister for Police and Corrective Services (Mr Barton) – That the Bill be now read a second time. Debate resumed.

- (a) a regulation declares the area to be a notified area under section 41: or
- (b) a magistrate disallows the order on the Minister's application.'.
