Order of the day read for the adjourned debate on the motion of the Treasurer (Mr Hamill) – That the Bill be now read a second time. Debate resumed.

*Distinguished visitors:* Mr Speaker informed the House of the presence in the Gallery of the Honourable Jeyaraj Fernandopulle, Sri Lankan Minister for Plan Implementation and Parliamentary Affairs, and his study tour delegation.

Debate continued. Debate adjourned on the motion of Mr Cooper. *Ordered* – That the resumption of the debate be made an order of the day for tomorrow.

#### 11 NOTICE OF MOTION - UNEMPLOYMENT RATE

Leader of the Opposition (Mr Borbidge), pursuant to notice, moved – That this House notes that Queensland has the second highest unemployment rate in mainland Australia and condemns the Beattie Government for its anti–jobs workplace relations policies and its continued failure to deliver on the Premier's blatantly opportunistic and cynical commitment of a 5% unemployment rate.

Debate ensued.

The following amendment was proposed by Premier (Mr Beattie)-

Delete all words after 'House' and insert the following-

'applauds the Queensland Government's ongoing commitment to job creation and job security, demonstrated by—

- 1. employment growth of 82,700 jobs in the past two years;
- 2. a reduction in the unemployment trend from 8.7% to 7.8%;
- 3. its strong commitment to Break the Unemployment Cycle for long term jobless and the young;
- 4. continued success in attracting international investors to establish operations in this State, such as Virgin Blue, Boeing, Bechtel and Red Hat;
- 5. implementing a capital infrastructure program in excess of \$15 billion, accounting for around one-third of all capital works undertaken by all State and Territory Governments around the nation in recent years; and
- active pursuit of private investment in major projects such as the Milmerran Coal Mine and power station, the PNG Gas Pipeline, Swanbank E gas-fired power station, the Comalco Alumina Refinery, Australian Magnesium plant at Stanwell, Dalyrymple Bay Coal Terminal and Airtrain Citylink.'.

Debate ensued.

Question put – That Mr Beattie's amendment be agreed to. The House divided.
