#### 1 MEETING OF THE HOUSE

The House met at 9.30am pursuant to adjournment. The Speaker (Honourable R K Hollis) read prayers.

#### 3 STATEMENT BY SPEAKER - ANNEXE TOWER LIFTS FAILURE ON 22 AUGUST 2000

Mr Speaker made the following statement—

'I wish to provide some information to Honourable Members in relation to yesterday's incident involving the Annexe Tower lifts, which resulted in some Members missing a division.

Having now been in receipt of a report from Property Services and our service maintenance contractors, I can report to the House that the problem was due to an overload of passengers for the lift car. While the car was carrying 18 passengers and its Rated Capacity is 23 – that rating is based upon 68 kilograms per person (as described by Australian Standards).

I have instructed Property Services to investigate changing the notified lift capacity from the officially Rated Capacity of 23.

I pass on the apologies of Property Services, and include my own apologies, to Members who were inconvenienced and distressed by yesterday's incident.

May I assure all Members that despite being some of the busiest in Brisbane, the lifts are maintained to the highest standard and are fitted with all the necessary safety features to meet the very demanding Australian Lift Code.'.

#### 14 MATTER OF PRIVILEGE

Leader of the Opposition (Mr Borbidge) rose on a matter of privilege suddenly arising and made the following statement—

'I rise on a matter of privilege suddenly arising. Earlier in question time the Premier suggested that I had misrepresented certain comments made by the Mayor of Townsville that were at odds with comments made to this House yesterday by his Parliamentary Secretary, the Member for Townsville, and the Premier refused to support either the mayor or the member. I wish to draw the attention of the House to what the Mayor of Townsville said.

My matter of privilege is that the Member for Townsville may have misled the House yesterday in giving this House certain assurances that are not consistent with the public comments made by the Labor Mayor of Townsville. Mr Speaker, to assist you in making this determination, I refer you to the Townsville Bulletin on Tuesday, 15 August, which states—

"The electoral forgery of Karen Ehrmann and Shane Foster played a big part in Mike Reynolds gaining preselection for the seat of Townsville, says his opponent in the contest, Townsville Mayor Tony Mooney.

Cr Mooney said Ehrmann and Foster had operated a concerted campaign to ensure he did not win the plebiscite against Mr Reynolds in 1996.

Asked if the activities of Ehrmann and Foster were crucial to the plebiscite vote, Cr Mooney said they 'had a big impact on the outcome.'

I submit that the comments made by the Labor Mayor for Townsville are not consistent with the assurances given to this House by the Labor Member for Townsville in regard to his alleged involvement in electoral fraud and corrupt activities.

Speaker's ruling: Mr Speaker ruled that there was no point of privilege.
