- a new 10 person unit to review and assess decisions made at local office level
- delivered 25 new SCAN co-ordinators
- doubled the number of senior staff in the regions
- launched a major community awareness campaign - "Things you need to know"
- delivered new and better training and mandatory professional development for child protection workers, as part of a drive to bolster the protection of Queensland children
- established an independent audit to assess all Queensland foster carers
- established a hotline to receive complaints
- almost doubled the number of front line child protection workers.'
