Mr McGrady accepted the nomination.

Leader of the Opposition (Mr Springborg) nominated George Edward Malone as Speaker of the House.

Motion seconded by the Deputy Leader of the Opposition (Mr Seeney).

Mr Malone accepted the nomination.

Mr O'Brien from 877 petitioners requesting the House to prevent the Justice Department from removing the ancient Mango and Curtain Fig trees from the Court House, Charlotte Street, Cooktown and seek other means available to manage these trees.

Mr Wellington from 755 petitioners requesting the House to support the terms of the Private Members Bill "Child Protection (Recognition of Relative Carers) Amendment Bill" addressing the issue that grandparents, as relative carers, receive no funding for caring for their grandchildren.

Mr McArdle from 42 petitioners requesting the House to reject any recommendations within the Crime and Misconduct Commission's report entitled "Regulating Adult Entertainment: A review of the live adult entertainment industry in Queensland" which expands the scope of this industry through legalisation of illegal activities, including Recommendations 7, 12, 15, 18 and 26, and to endorse recommendations from the report which protect minors and the community through enhanced regulation, enforcement and penalties.
