MEETING OF THE ASSEMBLY

The Assembly met at 9.30 am, pursuant to adjournment. The Speaker (Honourable A McGrady) read prayers.

STATEMENT BY SPEAKER - MATTER RAISED BY THE MEMBER FOR WARREGO

Mr Speaker made the following statement—

"Honourable Members-

I refer to the matter of privilege raised by the Member for Warrego yesterday who also wrote to me about the matter.

Given that the matter involves my actions in a former capacity, I have decided to delegate any decision making in this matter to the Deputy Speaker who will report to the House in due course.'

MOTION WITHOUT NOTICE - INDUSTRIAL RELATIONS AMENDMENT BILL -REMAINING STAGES THIS WEEK (Hansard p. 2356, 9.59 am)

Premier and Treasurer (Mr Beattie), by leave, moved - That so much of the Standing and Sessional Orders be suspended to enable the Industrial Relations Amendment Bill to pass through all remaining stages at this weeks sitting and that the debate of this Bill will commence following the passage of the Appropriation Bills.

This is to ensure:—

- That this Parliament does all it can to protect workers of Queensland and their families, from the harsh and unfair industrial relations proposals of the Howard Government that threaten families' take home pay and living standards; and

 - Penalty rates 0
 - Public holidays 0
 - Redundancy pay 0
 - Stand down provisions 0
 - Dispute settling procedures
 - Casual employment
