Brief History of the Autonomous Region of Bougainville (ARB)

The Bougainville Peace Agreement (BPA) signed in 2001, at the Arawa Independence Oval is a joint creation by the Independent State of Papua New Guinea (PNG) and the leaders of Bougainville to resolve the Bougainville Crisis and to secure lasting peace. The Agreement has three pillars. They are:

- 1. Autonomy
- 2. Referendum; and
- 3. Weapons Disposal.

BPA provides for an Autonomous Bougainville Government (ABG) operating under a home grown Bougainville Constitution.

The Bougainville House of Representatives

The Bougainville House of Representatives, a Post Conflict Parliament first met in 2005 fully represented by 33 Constituencies, three regional former combatants representatives, three regional women representatives, the popularly elected President, and the Speaker elected from outside by the elected leaders. It operates independently from the Executive Government and



developing its procedures and also establishing other functions to ensure it is compatible with other Parliaments in the Commonwealth of Nations.

The Bougainville Parliament became a member of the Commonwealth Parliamentary Association (CPA) in 2006. The first Speaker of the House, Mr.



PARLIAMENTARY EDUCATION SECTION

Why Parliamentary Education?

The Parliamentary Education Section develops and implements programs and services intended to increase the knowledge and understanding on the role and functions of the Parliament on Autonomy implementation and support the development of civics skills necessary for active citizenship.

Programmes

1) Inside Parliament Program:

This is a Radio Broadcasting Program aired on a weekly basis. It is aimed at disseminating parliamentary information on Governance of the Parliament which includes accountability and transparency and the progress of the committee work on certain issues.

a) Purpose of This Program:

Disseminating vital information to the communities in Bougainville is a challenge to both government and private sectors on the developments and other issues that have taken place since the implementation of the Bougainville Peace Agreement in 2005. The NBC regional radio station, Radio Bougainville *Maus bilong Sankamap* can be access by *60% of the total population of approximately 200,000* to keep the mandated leaders and the general public well informed on Parliamentary practices, Parliamentary Democracy and the government system.

b) Objectives:

The general public will be able to know and understand the systems of government and appreciate the roles and responsibilities of Members of the House of Representatives, the legislative body and meaningfully participate in the development of the Region through their respective Members of the HOR.

c) Program Implementation:

This program provides for the opportunity to the Key presenters to present and facilitate some important information about the functions of the Parliament and in respect to what they do in their offices and promote accountability and transparency, good governance and other related issues.

2) Youth Parliament Program:

This program is conducted in order to deepen the young people's understanding of parliamentary democracy. In doing so, young people will "learn by doing "and that is by taking part in youth parliaments or mock parliaments.

a) The Bougainville Youth Parliament 2007 and 2010

The first Bougainville Youth Parliament was conducted in 2007. It involved students from Hutjena Secondary School. It was staged at the Bel Isi Park of Buka Town where it captured the interest of a large crowd who also became the audience to witness the occasion.

The second Bougainville Youth parliament was conducted in the Parliament's Chamber on the 8th of March, 2010. The event was organized by the House of Representative to commemorate the year's Commonwealth Day.

Forty-five students of Bishop Wade Tarlena and Hutjena Secondary Schools were selected to participate in the event. It was a one day Mock Parliament

Session whereby students debated a proposed bill and participated in the question time session.

The main aims of both events were for Bougainville to commemorate the Commonwealth Day and also to signify the Bougainville House of Representatives Membership to the Commonwealth Parliamentary Association (CPA) in 2006.

Therefore as a member of the Commonwealth Parliamentary Association, BHOR is obliged to observe the Commonwealth Day annually and relevant activities such as the youth parliament is used to teach young people to understand how this parliament operates and understand the principles which underpin democracy. The theme for 2010 Commonwealth Day was "Science Technology Culture and Society".

b) 2011 Youth Forum

This Bougainville Wide Youth Forum was organized by the Division of Community Development in partnership with UNDP and was held in Arawa Youth Centre on the 29th August to 2nd September 2011.

The expected outcome of the Forum was to establish consensus on the Youth structures from the COE to the District and Regional Level. The Parliamentary Education Officer contributed meaningfully with a presentation on Youth and Parliament and an establishment of the net working with youths in the region.

c) International Youth Parliament

International Youth Parliament is another initiative by both Bougainville and the Solomon Islands Parliaments. Youth Parliament is an educational program that is targeted to young people to instil and promote democracy and governance. Young people participate in mock parliament sessions and other related activities such as quiz and essay competition. Selected students from Secondary Schools will travel to Honiara in 2012 to participate in the International youth Parliament. International Youth Parliament was originally planned to be held this year, 2011, however, the postponement was advised to the Solomon Islands Parliament by its Ministry of Youth, Churches and

Community Development which normally hosts this program for some reasons that it will be held in 2012.

d) The Bougainville Youth Parliament Manual (BYP)

The BYP Manual is a guide intended to assist Teachers and Youth leaders in the Region to help manage Youth Parliament Programs. Currently, there are no resources available in any way to assist on how community youths and also School students can go about conducting Youth Parliament programs. It is now an initiative the Education Section has developed and to promote the principles underpinning democracy thru the conduct of Youth Parliament Program. The manual contains some of the practices and procedures that reflect the Bougainville House of Representatives.

3) Forest for Children- Bougainville Program (FFC):

This parliament being a member of the Commonwealth Parliamentary Association is committed in supporting the United Nations Millennium Development Goal that is to promote the sustainability and management of the environment. This program involves and encourages schools and communities on the activity of reforestation.
