**The Parliament of Queensland enacts—** 1

**Clause 1 Short title** 3

This Act may be cited as the *Workers' Compensation and Rehabilitation and Other Legislation Amendment Act 2020*. 4

In this subdivision— 19

*eligible employee* see section 36EC. 20

*first responder* see section 36EB. 21

*relevant volunteer* means a person mentioned in 1  
division 3, subdivision 1 who is covered under a 2  
contract of insurance entered into with 3  
WorkCover for that subdivision. 4

**36EB Meaning of *first responder*** 5

A person is employed as a *first responder* if— 6

- (a) the person is a worker, or a relevant 7  
volunteer, employed in an occupation or 8  
profession prescribed by regulation; and 9
- (b) the person's employment requires the 10  
person to respond to incidents— 11
  - (i) that are life-threatening or otherwise 12  
traumatic; and 13
  - (ii) for which time may be critical to 14  
prevent actual or potential death or 15  
injury to persons, or to prevent or 16  
minimise damage to property or the 17  
environment. 18

**36EC Meaning of *eligible employee*** 19

(1) A person is employed as an *eligible employee* if— 20

- (a) the person is a worker, or a relevant 21  
volunteer, employed by or in an entity 22  
prescribed by regulation; and 23
- (b) the person's employment requires the 24  
person to experience repeated or extreme 25  
exposure to the graphic details of traumatic 26  
incidents by— 27
  - (i) attending the scenes of traumatic 28  
incidents; or 29

*Example of a person for subparagraph (i)—* 30

a person whose employment requires the 31  
person to recover human remains 32

<b>36ED Presumption of injury</b>	22
(1) This section applies in relation to a person who—	23
(a) is diagnosed by a psychiatrist, in the way prescribed by regulation, as having post-traumatic stress disorder; and	24 25 26
(b) at any time before the diagnosis, was employed as a first responder or an eligible employee.	27 28 29
(2) For the purposes of an entitlement to compensation, the post-traumatic stress disorder is taken to be an injury.	30 31 32
(3) Subsection (2) applies despite any evidence that	33

	the post-traumatic stress disorder arose out of, or	1
	in the course of, a circumstance mentioned in	2
	section 32(5)(a), (b) or (c).	3

(c)	there is no evidence that the claimant has	26
	been diagnosed by a psychiatrist as having	27

(2)	The insurer must—	29
(a)	arrange for the claimant to be examined by a	30
	psychiatrist to obtain a diagnosis; and	31
