MR HOBBS asked the Minister for State Development and Innovation (MR McGRADY) —

QUESTION:

For each of 2001-02, 2002-03 and 2003-04 (reported separately for each year), will he provide details on the following —

- (1) How many businesses, multinational clients and corporations has the Government attracted from New South Wales to Queensland?
- (2) What was the type and value of the assistance provided in each individual case including any financial assistance or land deals to attract these businesses, multinational clients and corporations from New South Wales to Queensland?

ANSWER:

- (1) The following businesses relocated specific operations from New South Wales with the support of QIIS agreements signed in the financial years as indicated.
