## Question on Notice No. 280 Asked on 7 March 2006

Mr SPRINGBORG asked the Premier (Mr Beattie) -

## QUESTION:

As the Minister responsible for the Ministerial Services Branch will he advise

(a) which Ministerial media and marketing staff have been seconded from a State Government department and from which Government department (reported separately),

(b) what is the substantive position of each of these staff prior to being seconded,

(c) what is the classification and salary bracket of each substantive position of each of these staff members and

(d) what is the classification and salary bracket of each of these staff in their seconded position set out in the following format?

## ANSWER:

(a) As you would know from your time as a Minister in the Borbidge Government, this is not an unusual practice. In fact, I am aware of seven ministerial media staff during the Borbidge Government who held substantive positions as permanent public servants within Government agencies. There are currently eight ministerial media staff who hold substantive positions as permanent public servants within Government agencies.

(b) Details of the substantive positions and classification levels of individuals appointed as permanent public servants are notified through the Queensland Government Gazette.

(c) The specific classification level that an individual is appointed to within a Ministerial Office is personal information.

(d) The name, current ministerial position, substantive position, and classification in substantive position are set out in the table below.
