MR KNUTH MP asked the Minister for Communities, Disability Services and Seniors (**MR PITT**) -

For each of the last two financial years and the year to date (reported separately), will he provide details of support grants to organisations assisting victims of crime and domestic violence including (a) name of organisation and amount of all grants to any domestic violence support groups or programs and (b) name of organisation and amount received of all grants to any victims of crime support groups or programs?

ANSWER:

In the 2003-04 financial year 101 services or projects totalling \$25.1M and in the 2004-05 financial year 130 services or projects totalling \$26M were funded by the Department of Communities to assist victims of domestic violence. In the 2005-06 financial year 143 services or projects were funded to an amount of \$28.4M. A list of organisations receiving these funds is attached.

There are six funded victims of crime services. Over the last three financial years funding has increased from \$1.3M to \$1.4M. A list of organisations receiving these funds is attached.

In addition to the wide range of services for women and children affected by domestic and family violence, the department has committed \$3.75M over four years 2004–08 for the enhancement of services to assist perpetrators in changing their abusive behaviour.
