**MR HORAN** asked the Minister for Primary Industries and Fisheries (MR MULHERIN)—

**QUESTION:**

What is the total cost of outsourced legal services provided for his department for 2003-04, 2004-05 and 2005-06 (reported separately) and who provided the legal work undertaken by each legal service provider (reported separately)?
