MR ROBERTS asked the Minister for Health (MR ROBERTSON)-

QUESTION:

Will he provide details (organisation, funding, purpose) on Health and Community Care funding provided to organisations in the Nudgee Electorate for the current and previous financial years?

ANSWER:

The Home and Community Care Program (HACC) is a national joint Australian/State Government funded program. It provides a range of basic maintenance and support services which allow people to be more independent at home and in the community. HACC eligible clients are the frail aged, younger people with disabilities, and their carers.

In the 2004-05 financial year non-government service providers in the Nudgee Electorate received recurrent operating funds of \$2,721,374. In addition, there is one service provider, Queensland Aged & Disability Advocacy Inc., providing statewide services that received recurrent operating funding of \$636,423, giving a total of \$ 3,357,797.

In the 2005-06 financial year non-government service providers in the Nudgee Electorate received recurrent operating funds of \$3,115,374, with the above statewide service provider receiving recurrent operating funding of \$691,304, giving a total of \$3,968,949.

As an outcome of the 2005-06 HACC funding round non-government service providers in the Nudgee Electorate will receive an additional \$162,271 recurrent operating funds and \$161,573 non operating funds.
