# Question on Notice No. 974 Asked on Tuesday 6 June 2006

**MR HOBBS** asked the Minister for Environment, Local Government, Planning and Women (MS DESLEY BOYLE)—

### QUESTION:

With reference to Freedom of Information (FOI) applications received by agencies within her portfolio, including the ministerial office for 2002-03, 2003-04, 2004-05 and current financial year to date—

- (1) What are the total numbers of personal and non-personal FOI applications received (reported separately)?
- (2) What was the total of fees and charges levied in respect of personal and non-personal applications (reported separately)?
- (3) In respect of non-personal FOI applications, how many applicants have sought internal and/or external review of decisions regarding the levying of time-based charges (reported separately)?

#### ANSWER:

### **Environment Portfolio**

The table below outlines the number of personal and non-personal applications for the financial years 2002-03, 2003-04, 2004-05 and current financial year to date for the Freedom of Information Unit of the Environmental Protection Agency and its associated agencies.

With reference to the total of fees and charges levied, it should be noted that the *Freedom of Information Regulation 1992* does not allow the levying of fees and charges for personal applications.

With reference to internal reviews or external reviews for the levying of time based charges for 2002-03, 2003-04, 2004-05 and current financial year, there has been only one internal review in the 2004-05 financial year and no external reviews.
