# QUESTION:

With reference to Freedom of Information (FOI) applications received by agencies within his

portfolio, including the ministerial office for 2002-03, 2003-04, 2004-05 and current financial vear to date—

- (1) What are the total numbers of personal and non-personal FOI applications received (reported separately)?
- (2) What was the total of fees and charges levied in respect of personal and non-personal applications (reported separately)?
- (3) In respect of non-personal FOI applications, how many applicants have sought internal and/or external review of decisions regarding the levying of time-based charges (reported separately)?
