MR HOPPER asked the Minister for Transport and Main Roads (MR LUCAS)—

QUESTION:

With reference to Freedom of Information (FOI) applications received by agencies within his portfolio, including the ministerial office for 2002-03, 2003-04, 2004-05 and current financial year to date—

(1) What are the total numbers of personal and non-personal FOI applications received (reported separately)?

(2) What was the total of fees and charges levied in respect of personal and non-personal applications (reported separately)?

(3) In respect of non-personal FOI applications, how many applicants have sought internal and/or external review of decisions regarding the levying of time-based charges (reported separately)?

ANSWER:

I thank the Honourable Member for his question with reference to applications received by my portfolio agencies under the provisions of the *Freedom of Information Act 1992*.

In response to questions One and Two, the attached tables detail the applications received by the respective portfolio agencies and also the amount of fees and charges they collected for the 2002-2003, 2003-04, 2004-05 and 2005-06 financial periods.
