Question on Notice No. 498 Asked on 15 March 2007

MR SEENEY asked the Premier and Minister for Trade (MR BEATTIE) -

QUESTION:

With reference to any reserve, contingency or emergency funding, or funding used for one-off grants, expended by his department/s at the discretion of the minister or chief executive officer—

- (1) Will he provide for 2005-06 and 2006-07 to date, details of all items of expenditure from such fund/s and or one-off grants including (a) reason for expenditure, (b) total amount, (c) the date each item of expenditure was approved and (d) the person/s responsible for approval of expenditure?
- (2) What is the uncommitted balance of these funds at present?
- (3) Why are the reserve or contingency funding or one-off grants used rather than approved grant funds?

ANSWER:

The contingency fund provides the capacity and flexibility for the Premier of the day to respond to emergent needs and events.

As Head of Government, I am approached in that capacity to facilitate a variety of initiatives of economic, social, regional and environmental importance to Queensland.

The nature and type of projects undertaken is highly influenced by the public agenda. Hence, flexibility, together with the ability to rapidly respond and act on new issues as they emerge is imperative.

My ability to respond effectively to emerging issues and opportunities is dependent on immediate access to appropriate levels of resources. Adequate financial resources are therefore essential if these demands are to be met on a timely basis, particularly those which emanate from unforseen events or those which require expeditious decisions and actions.

The contingency fund is also available to provide whole of Government contributions to charitable organisations and disaster appeals and to provide assistance to local authorities, deserving causes and community groups.

The attached table (Attachment A) lists expenditure approved from the contingency fund in the 2006-07 financial years as at 28 February 2007. Please note information on the contingency fund expenditure for 2005-06 can be found in the tabled response to a previous Question on Notice: no.533 asked by Bob Quinn on April 20 2006.

The Premier of the day having access to a contingency fund is not new. By way of comparison, former Premier Borbidge had a funding allocation in his department's contingency reserve totalling \$14.984 million in the 1997-98 financial year. Total expenditure at 30 June 1998 as detailed in Attachment B was \$10.7 million. This is in comparison to contingency expenditure totalling \$8.34 million in 2005-06.
