Question on Notice No. 516 Asked on 15 March 2007

MR NICOLLS asked the MINISTER FOR TOURISM, FAIR TRADING, WINE INDUSTRY DEVELOPMENT AND WOMEN (MRS KEECH) –

QUESTION:

With reference to any reserve, contingency or emergency funding, or funding used for one-off grants, expended by her department at the discretion of the minister or chief executive officer—

- (1) Will she provide for 2005-06 and 2006-07 to date, details of all items of expenditure from such fund/s and or one-off grants including (a) reason for expenditure, (b) total amount, (c) the date each item of expenditure was approved and (d) the person/s responsible for approval of expenditure?
- (2) What is the uncommitted balance of these funds at present?
- (3) Why are the reserve or contingency funding or one-off grants used rather than approved grant funds?

ANSWER:

With reference to my response to the above question tabled on 16 April 2007, I have been advised by my Director-General that the original answer incorrectly refers to the requirement that amounts of more than \$350,000 paid prior to 14 December 2006 required Ministerial approval. That amount should have been \$375,000.*

My Director-General has also provided a more detailed break down of certain payments from the fund. It includes an amount not contained in my previous answer.

The department maintains a reserve for emergent and unforeseen events.

The attached table (Attachment A) lists expenditure made from reserve, contingency or emergency funding, or one-off grants in the 2005-06 and 2006-07 financial years as at 28 February 2007.

The balance of these funds is fully committed.

The department does not have an approved grant fund program. Payments of one-off grants are made from operational funds.
