QUESTION:

MR HORAN asked the Minister for Environment and Multiculturalism (Ms Nelson-Carr)—

With reference to page 4 of the Review of the Roles and Responsibilities of Natural Resources Minerals and Water, Environmental Protection Agency and Department of Primary Industries and Fisheries which refers to 'delays being experienced in obtaining approvals for amendments to Regional Ecosystems maps, and in getting Property Maps of Assessable Vegetation (PMAVs) approved'—

Will she provide the (a) number of applications received for amendments to Regional Ecosystems maps, including a breakdown by local government area, (b) number of applications for amendments to Regional Ecosystem maps that have been approved to date, including a breakdown by local government area, (c) average time that it has taken to process applications, the average time of approval and a breakdown of the average time of approval by local government area and (d) longest time taken for a PMAV approval and the longest time taken for approval of amendments to Regional Ecosystem maps?

ANSWER:

The EPA is responsible for maintaining the regional ecosystem maps, working with the Department of Natural Resources and Water (DNRW), consultants and the public on map modification assessments and implementation. DNRW is responsible for the Property Maps of Assessable Vegetation (PMAV) assessments. While DNRW does involve the EPA in some regional ecosystem map modification assessments associated with PMAVs, most PMAVs are not referred to the EPA.

In response to Parts (a) and (b) of your question, there have been 3,054 applications received and processed for regional ecosystem map assessment requests between January 2000 and 19 June 2007. A further 40 map assessment requests are currently being processed as at 19 June 2007. The breakdown by Local Government Area for regional ecosystem map assessment requests is provided in the table below.

In response to Parts (c) and (d) of your question, the average time for processing regional ecosystem map requests was 54 days, the median time 28 days and the longest time was 600 days (including weekends and public holidays). Note the longest time request was not for tree clearing, vegetation management but was for improving the accuracy of the mapped remnant vegetation of the property. The graph provided below shows that over 80% of regional ecosystem requests are processed within 100 days.

The process to amend the regional ecosystem mapping initially involves a desktop analysis using resources such as historical aerial photographs, multi-age satellite imagery, geology and soil maps. However field data, such as the height and species of trees and shrubs present, is often required to make an accurate decision on the remnant status of the vegetation. In addition, clients are required to provide adequate information to allow an assessment to occur.

Some Map Assessment requests have taken longer to finalise for a number of reasons:

- Insufficient information was provided by clients to justify the map changes requested in the first instance. Delays in clients' responses to the EPA's follow-up requests were lengthy. Procedures have now been instigated whereby these types of requests are handled more efficiently during the assessment process.
- Some of the Map Assessment Requests were associated with Department Natural Resources and Water Compliance and Appeals cases. Finalisation of these cases is dependent on court or tribunal proceedings, which took significant time-periods to complete.
- Some delays were associated with both the Request Vetting System and Priority System instigated by the Herbarium in dealing with Map Assessment Requests. Priority was given to Ministerial issues (both Environment and Natural Resources and Water), mining requests, Vegetation Management Act tree clearing requests, ballot requests, and fodder and forest practice requests. Other requests may have been subsequently delayed due to this prioritisation.
