MR DEMPSEY ASKED THE MINISTER FOR CHILD SAFETY AND MINISTER FOR SPORT (MR REEVES)—

Will the Minister advise the number and value of grants given to non-government organisations in 2008–09 for the delivery of child safety services (reported by entity and type of service)?

ANSWER:

The Bligh Government is committed to strong partnerships with the non-government sector. This is demonstrated through significant investment to deliver services such as placements, counselling and intervention.

Over the past five years, this Government has more than tripled the budget and doubled the workforce for child protection in Queensland. Today the Bligh Government invests \$638 million into protecting Queensland's most vulnerable children and young people. The last time the Nationals were in power, their budget papers showed only a \$35 million investment in child protection.

The support of non-government services to protect Queensland's most vulnerable children and young people is deeply valued by the Bligh Government.

In 2009–10, the Bligh Government will invest over \$25.3 million in new placement funding to improve the diversity and stability of placements for children and young people across Queensland.

As the Member should be aware, the Bligh Government also committed an additional \$414 million to support our non-government partners following a recent Queensland Industrial Relations Commission decision to increase wages across the community sector.

Other highlights from the 2009–10 record budget of \$638 million for Child Safety Services are listed below:

- Child protection in 11 Indigenous communities will be strengthened with a focus on providing an immediate 'safe place' within the community. Capital funding of \$9.9 million in 2009–10 will continue the establishment of facilities to ensure children who require out-of-home care are provided the opportunity to remain connected to their family, community and culture.
- Family intervention services that provide practical advice and support to 1,700 families will receive a \$2 million boost in 2009–10.
- Front-line staff will benefit from continuing career progression opportunities with \$15.1 million allocated over four years to improve staff retention and development.
- An innovative Indigenous youth mentoring services program in south-west Queensland, focused on reducing the number of children and youths entering the child protection and youth justice systems, will receive \$2.3 million over three years.

Details of the 302 grants given to non-government organisations in 2008–09 for the delivery of child safety services reported by entity and type of service for a total value of \$123,209,266.50 are provided in the attached table.
