MR KNUTH asked the Minister for Child Safety and Minister for Sport (MR REEVES)—

QUESTION

Will the Minister advise for each Child Safety Service Centre (reported separately), the total operational budget and total expenditure for 2010–11?

ANSWER

The Bligh Government is strongly committed to protecting Queensland's most vulnerable children and young people. The 2011–12 budget includes an investment of \$733 million in Child Safety Services to ensure our children have every opportunity to reach their full potential.

With regard to the budgets for individual child safety service centres, I refer the Member to my response to Question on Notice No. 4, tabled on 20 July 2010.

The total expenditure, up to 30 June 2011 (unaudited actuals), for each Child Safety Service Centre is provided in the following table.
